A BILL FOR AN ACT

RELATING TO THE HURRICANE RESERVE TRUST FUND.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 237-31, Hawaii Revised Statutes, is
amended to read as follows:

3 "§237-31 Remittances. All remittances of taxes imposed by this chapter shall be made by money, bank draft, check, 4 5 cashier's check, money order, or certificate of deposit to the 6 office of the department of taxation to which the return was 7 transmitted. The department shall issue its receipts therefor 8 to the taxpayer and shall pay the moneys into the state treasury 9 as a state realization, to be kept and accounted for as provided 10 by law; provided that:

11 (1) A sum, not to exceed \$5,000,000, from all general excise tax revenues realized by the State shall be deposited in the state treasury in each fiscal year to the credit of the compound interest bond reserve fund; 15 [-(2) A sum from all general excise tax revenues realized by 16 the State that is equal to one half of the total amount of funds appropriated or transferred out of the
