> In consideration of House Bill 1981 H.D. 1 Relating to Traffic Violations

Honorable Chair Tarnas, Honorable Vice-Chair Takayama, and Committee Members:

The Kaua'i Police Department (KPD) **supports** House Bill 1981 H.D. 1 Relating Traffic Violations, which specifies that a portion of the revenues collected from traffic violations shall be disbursed to the county that enforces the violation.

The steady increase in tourism on Kaua'i has had negative consequences on our island's roadways. Specifically, state highways adjacent to beach parks and other areas of public interest are often congested by illegal stopping, standing, and parking thereby impeding the regular flow of traffic.

The regulation of traffic laws and parking enforcement falls predominantly upon county law enforcement agencies. Disbursing funds to the county from where the enforcement the traffic violations are conducted will assist to offset the costs associated with enforcement.

For this reason the Kaua'i Police Department (KPD) **supports** House Bill 1981 H.D. 1 Relating Traffic Violations.

- 2. This measure provides an equitable way to share the responsibility of maintaining public safety for residents and visitors between the State and the counties.

HB1981 HD1 RELATING TO TRAFFIC VIOLATIONS

Dear Chair Tarnas, Vice Chair Takayama, and Committee Members,

The Oahu Metropolitan Planning Organization (OahuMPO) supports HB1981 HD1.

This measure is consistent with several goals of the Oahu Regional Transportation Plan including supporting a reliable and efficient transportation system and improving the safety of the transportation system. As traffic fines currently go to the state only, this measure would benefit the counties in ensuring all roads and highways remain safe and unobstructed. In addition, the fines can be used by the police department to increase enforcement across our communities to provide the necessary resources to carry out the enforcement's purpose.

The OahuMPO is the federally designated Metropolitan Planning Organization (MPO) on the island of Oahu responsible for carrying out a multimodal transportation planning process, including the development of a long-range (25-year horizon) metropolitan transportation plan, referred to as the Oahu Regional Transportation Plan (ORTP) that encourages and promotes a safe and efficient transportation system to serve the mobility needs of people and freight (including walkways, bicycles, and transit), fosters economic growth and development, and takes into consideration resiliency needs, while minimizing fuel consumption and air pollution (23 CFR 450.300).

Ulupono Initiative <u>supports</u> HB 1981 HD1, Relating to Traffic Violations.

Dear Chair Tarnas and Members of the Committee:

My name is Micah Munekata, and I am the Director of Government Affairs at Ulupono Initiative. We are a Hawaiʻi-focused impact investment firm that strives to improve the quality of life throughout the islands by helping our communities become more resilient and self-sufficient through locally produced food, renewable energy, clean transportation choices, and better management of freshwater resources.

Ulupono supports HB 1981 HD1, which specifies that a portion of the revenues collected from traffic violations shall be disbursed to the county that enforced the violation.

Ulupono supports the counties' ability to collect 50% of the revenues collected from traffic violations. With additional resources, counties can better serve our communities with roads that are safe and unobstructed.

Many may think that enforcement of parking rules is just a revenue ploy, but in many places unenforced and poor parking management leads to more chaotic outcomes.¹ In contrast, equitable and consistent parking enforcement can be a very important tool in how we manage our public spaces—specifically our streets. As our counties reform and update their on-street parking policies, as the City and County did recently with Ordinance 23-27, improved enforcement is key for success.

Historically, the revenues from these violations have remained with the State to cover the costs of tickets and adjudication—a good portion of which is now online and automated. As a result, the financial benefits of enforcement are not shared with those that pay for enforcement, thus leading to under-resourced or absent enforcement. In the 2015 Honolulu Urban Core Parking Master Plan, a lack of enforcement was noted and likely "...symptomatic of the HPD's budgetary limits and/or the fact that HPD may not be motivated to write citations because it does not retain any parking citations income." This bill helps to share the fiscal benefits across the counties and the State more equally considering their respective contributions.

In addition, we would also recommend that counties have more flexibility in staffing such enforcement programs. Currently, only county employees or officers may enforce parking as per HRS 291C-167. It would be a great improvement if the counties were also able to employ the same flexibility as the University of Hawai'i in using parking managers or other authorized personnel (including private concessionaires) to enforce parking rules. This can also include using more automated enforcement mechanisms as the technologies develop and are employed across the state.
