TESTIMONY TO THE HOUSE COMMITTEES ON HOUSING, AND HEALTH AND HOMELESSNESS

House Bill 2324 - Relating to Housing

The Disability and Communication Access Board (DCAB) offers comments on House Bill 2324 – Relating to Housing.

This bill addresses the housing crisis by appropriating funds for prefabricated, modular, or kauhale-type housing for homeless individuals and low income households.

The housing crisis is magnified for people with disabilities. People with disabilities are twice as likely to live below the poverty level.

In addition to addressing the temporary housing shortage, legislation should address the quantity of supportive temporary housing units that are accessible to people with mobility and communication disabilities. The Americans with Disabilities Act Standards for Accessible Design (ADA Standards) specifies the minimum percentage of accessible temporary housing units in public facilities. The ADA Standards only requires five percent of units to be accessible for mobility disabilities and two percent of units to be accessible for communication disabilities.

According to the U.S. Census Bureau's 2021 Disability Characteristics for the State of Hawaii, 19.1 percent of Hawaii's residents that are sixty five years and older have mobility difficulty, 12.6 percent have hearing difficulty, and 4.7 percent have vision difficulty. The following adjustments that exceed minimum accessibility and adaptability requirements would help ensure Hawaii residents with disabilities are able to access the services funded by this bill.

- In public facilities with temporary housing units, at least twenty percent, but no fewer than one unit, of the total number of the units shall provide mobility features that comply with applicable technical requirements in the ADA Standards.
- In public facilities with temporary housing units, at least thirteen percent, but no fewer than one unit, of the total number of units shall provide communication features that comply with applicable technical requirements in the ADA Standards.

Investing in accessible, temporary housing would ensure that people with disabilities who are homeless or low income are not excluded from this program.
