### Chair Gates and Members of the Committee:

The Department of the Attorney General provides the following comments:

The purpose of this bill is to establish an aquaculture advisory committee within the Department of Agriculture.

We note that the bill does not contain a provision specifying whether the members of the advisory committee should serve without compensation as recommended by the Hawaii Legislative Drafting Manual (item 10 on page 71).

Accordingly, we recommend adding to the new section being added to chapter 141, Hawaii Revised Statutes, by section 1 of the bill, on page 2, beginning at line 19, a new subsection (e) to read as follows:

(e) The members of the aquaculture advisory committee shall serve without compensation but shall be reimbursed for expenses, including travel expenses, necessary for the performance of their duties.

In the alternative, this provision could be added to subsection (b) of the new section at page 2, line 9.

### HOUSE BILL NO. 2617 RELATING TO AQUACULTURE

Chair Gates, Vice Chair Kahaloa, and Members of the Committee:

Thank you for the opportunity to testify on House Bill 2617. The bill establishes the Aquaculture Advisory Committee within the Department of Agriculture; declares that the general fund expenditure ceiling is exceeded; and makes an appropriation. The Department offers comments.

The establishment of an Aquaculture Advisory Committee creates an unnecessary bureaucratic layer in the State's aquaculture development sector. Historically, the Hawaii Aquaculture Advisory Council (HAAC) was established in 1998 and was abolished in 2000. The reasoning for HAAC abolishment was the establishment of an effective statewide industry organization, the Hawaii Aquaculture Association (now Hawaii Aquaculture and Aquaponics Association). The association provides the department industry and technical perspective on the sector.

Aloha Chair Gates, Vice-Chair Kahaloa, and Members of the Committee:

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate and advance the social, economic, and educational interests of our diverse agricultural community.

**The Hawai** Farm Bureau supports HB 2617, which establishes the Aquaculture Advisory Committee within the Department of Agriculture.

Hawai'i's aquaculture industry farm gate value is \$80,000,000, the second-highest contribution to the economy in diversified agriculture. Hawai'i's favorable climate and geography allow for inherent advantages benefitting aquaculture production.

The Legislature acknowledged the importance of Hawai'i's aquaculture industry by revitalizing the Aquaculture Development Program through Act 63, SLH 2019. However, more investment and research into the aquaculture industry is needed, including investment and research into different types of aquaculture, aquaculture system optimization, and economic implications of various methods of aquaculture production.

An Aquaculture industry-led advisory committee can help strengthen and grow Hawai'i's aquaculture industry, bringing in investment, producing high-quality seafood, and increasing the State's economic resilience and food sustainability.
