### **Department's Position:**

The Hawaii State Department of Education (Department) respectfully provides comments on HCR 0170.

In order to comprehensively address the behavioral and mental health needs of students, the Department has strategically established a range of positions dedicated to providing support and intervention. These positions encompass a diverse array of roles and responsibilities, each tailored to address specific aspects of students' well-being and development. Specifically, the Department has established the following positions to address the behavioral and mental health needs of students:

School Counselors - 677 Behavioral Health Specialists (BHS) - 306 Clinical Psychologists - 53 School Psychologists - 94 Social Workers/Human Services Professionals - 82 Total established positions = 1,212

Of the 1,212 established positions, approximately 90% are filled. This equates to 1,086 Department behavioral and mental health staff who provide indirect and direct services to students. Additionally, to enhance the Department's workforce, it has partnered with Hazel Health and Hawaii Keiki to deliver supplementary behavioral and mental health services statewide. Therefore, the Department has the capacity to address the needs of its 167,649 public school students with a current ratio of 1 provider

to 154 students, which is well below the recommended ratio of 1 to 250 students. Furthermore, the Department is proactively involved in assessing and implementing activities for system improvement.

Additionally, to maintain the current workforce and attract future personnel, the Department seeks to ensure that the current §453D-1 exemption, which waives the licensure requirement for state employees, is respected.
