#### SENTATE BILL 2710 RELATING TO CULTURE AND ARTS

Dear Chair Lee and members of the Committee, The State Foundation on Culture and the Arts (SFCA) **SUPPORTS** S.B. 2710 which establishes the Hawai'i Leadership Awards Program to honor individuals who have made considerable and outstanding contributions to Hawai'i and inspire others.

The SFCA has a long history of recognizing outstanding individuals in Hawaii with awards. From 1970 to 2019, the SFCA issued 118 awards in the categories of State of Hawai`i Order of Distinction for Cultural Leadership, Governor's Award for Distinguished Achievement in Culture, Arts and Humanities, Hawai`i Award for Literature, Individual Artist Fellowships and the Hawaiian Architectural Award. Introducing the Leadership Award as described in SB2710 would fall within the purview of the SFCA.

In 2009, State funding to the SFCA to support the staff coordinator position and the awards was abolished. Until that time, awards were regularly given from 1970 through 2008. Consistent appropriation from the legislature in support of recognizing leadership in our community will benefit the State's overall economy. When we celebrate Hawaii's achievements, we invest in the economic stability of Hawai`i.

The SFCA's awards process is outlined in our establishing legislation under HRS Chapter 9. SFCA review panels are selected per <u>Hawaii Administrative Rules</u> and composed of members of the community at large who are knowledgeable and experienced in the subject matter of the panel on which they serve. All panel members serve without compensation.
