SENATE CONCURRENT RESOLUTION 123/ SENATE RESOLUTION 105 URGING THE DEPARTMENT OF LAND AND NATURAL RESOURCES TO CONVENE A WORKING GROUP TO MAKE RECOMMENDATIONS ON SOLUTIONS TO REDUCE WILDFIRE RISK AND THE FEASIBILITY OF ESTABLISHING A VEGETATION MANAGEMENT PROGRAM AS IT RELATES TO LANDOWNERS AND PUBLIC UTILITIES

Senate Concurrent Resolution 123 and Senate Resolution 105 urges the Department of Land and Natural Resources (Department) to convene a working group to make recommendations on solutions to reduce wildfire risk and the feasibility of establishing a vegetation management program as it relates to landowners and public utilities. **The Department supports the intent of these resolutions and provides the following comments.**

The Department recognizes the need for vegetation management across public and private property and the Department would be a willing participant in any working group that the legislature establishes. However, the Department is concerned that establishing a working group without appropriating funds for the administrative support needs of the group would place an unfunded mandate on the Department that would consume substantial time and resources. The Department prefers the establishment of a working group by Senate Bill 2842 Senate Draft 2, which establishes a broader focused working group on the state's overall wildfire preparedness and mitigation strategies. SB2842 SD2 appropriates funding for the administrative staff position. This group should be able to develop the framework for vegetation management across

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the State recognizes 2 the increasing threat of wildfires to our communities, natural 3 resources, and economy and that the State is committed to 4 proactively addressing this growing challenge through a 5 comprehensive and collaborative approach. Understanding the 6 need for a multifaceted strategy, the legislature further finds 7 that a working group comprising government agencies, fire 8 experts, landowners, and stakeholders is required to identify 9 solutions that address the State's wildfire preparedness and 10 mitigation challenges and improve the State's wildfire 11 preparedness and mitigation practices.

Accordingly, the purpose of this Act is to establish awildfire mitigation working group.

SECTION 2. (a) There is established within the department of land and natural resources a wildfire mitigation working group to develop a state wildfire mitigation plan and to advise

Chair Inouye, Chair Wakai, and Members of the Committees:

My name is Michael Angelo, and I am the Executive Director of the Department of Commerce and Consumer Affairs (Department) Division of Consumer Advocacy. The Department provides comments on this resolution.

The purpose of this resolution is to request the Department of Land and Natural Resources (DNLR) to convene a working group (Working Group) to make recommendations on solutions to reduce wildfire risk and the feasibility of establishing a vegetation management program as it relates to landowners and the public utilities. In addition, the resolution requests: (1) that the Working Group study the need for policy, regulation, and guidance pertaining to the management of and responsibility for

vegetation on public and private lands for wildfire mitigation purposes; (2) that the Working Group study, evaluate, and make recommendations regarding regulations that define property owner obligations to preform vegetation management on public and private property for wildfire mitigation purposes; (3) that the Chairperson of the Board of Land and Natural Resources or the Chairperson's designee serve as the chairperson of the Working Group; (4) that a representative of the Division of Consumer Advocacy of the Department, whose purview includes the public utilities, serve as a member of the Working Group; (5) that the Working Group submit a report of its findings and recommendations, including any proposed legislation, to the Legislature no later than 20 days prior to the convening of the Regular Session of 2025; and (6) to dissolve the Working Group on June 30, 2025.

The tragedy and devastation of the wildfires that arose on Maui during the August 8, 2023, windstorm must be prevented from reoccurring. Vegetation management (including the creation of firebreaks and the removal of buildup of flammable vegetation), is viewed as essential for the mitigation of wildfire risks and the promotion of safer conditions for our communities and the environment. Thus, the Department supports the convening of a Working Group to, among other things, make recommendations on solutions to reduce wildfire risk and the feasibility of establishing a vegetation management program as it relates to landowners and public utilities, as advanced by this resolution.

The Department offers that any review of vegetation management should also consider the wildfire mitigation actions that are being proposed as part of the Hawaiian Electric Company's Climate Adaptation Transmission and Distribution Resilience Program in Docket No. 2022-0135 and the electric utilities' (including Kauai Island Utility Cooperative) hazard mitigation plans to be filed with the Public Utilities Commission (Commission) in the next few months, in response to Commission Order No. 40396. Such plans will be filed as part of a non-docketed proceeding under Case No. 2023-04661.

The Public Utilities Commission ("Commission") offers the following comments for consideration.

COMMENTS:

The Commission appreciates the intent of these Resolutions to find solutions to reduce wildfire risk and the possibility of establishing a vegetation management program as it relates to landowners and public utilities.

The Commission observes several major challenges to vegetation management and landowner compliance that could be addressed by this Working Group. These include fragmented and overlapping responsibilities, lack of consistent statewide data, lack of resources, authority, and motivation, and a poor understanding of cost-effectiveness of SCR 123/SR 105 Page 2

different approaches to vegetation management.¹ The Commission agrees with the Resolutions that there is a need to define property owner obligations to perform vegetation management on public and private property. To this end, it may also be beneficial for the Working Group to create or review maps that define areas of the state in which the financial responsibility of preventing and suppressing fires lies with the state.

The Commission is amenable to serving as a member of the Working Group and looks forward to participating. The Working Group's findings and recommendations will complement the Commission's efforts to further develop requirements for and evaluate utility vegetation management programs and wildfire protection plans.

The International Brotherhood of Electrical Workers Local 1260 (IBEW 1260) would like to respectfully offer the following testimony in **Support** of Senate Concurrent Resolution 123 (SCR 123) with a requested amendment to include a representative from the International Brotherhood of Electrical Workers, Local 1260.

IBEW 1260 is comprised of approximately 3,000 members representing Hawaii's electric utility companies as well as Government Service Contracts throughout Hawaii, Guam, and Wake Island. Our members are a diverse local workforce of dedicated, highly skilled, and trained individuals working 24 hours a day, 7 days a week, to generate, transmit, and distribute electricity throughout Hawai'i and to ensure the reliability of this precious resource.

IBEW 1260 supports SCR 123 requesting the Department of Land and Natural Resources to convene a working group to make recommendations on solutions to reduce wildfire risk and the feasibility of establishing a vegetation management program as it relates to landowners and public utilities.

As noted in SCR 123, utility companies in the State have miles of utility lines installed throughout the State on government and private lands, and that a significant portion of these lands are covered in unmanaged grasses, trees, and other vegetation that may pose a wildfire risk. Tree Trimming is categorized as one of the most dangerous jobs in the nation, but when you add tree trimming at or near energized electric power lines, risks are exacerbated one-hundred-fold.

IBEW1260 represents workers that perform this scope of work and theirs as well as the public's safety is of paramount concern. A similar measure introduced in the House (HCR148) included a representative from IBEW1260. Having a seat at the table to speak on behalf of those that will ultimately perform such hazardous work will ensure public and worker safety is considered. We respectfully request an amendment to SCR123 to include a representative of IBEW 1260 as a member of the working group.
