Chair Gates, Vice Chair Kahaloa and Members of the Committee:

Thank you for the opportunity to testify on Senate Concurrent Resolution No.

129, SD1 that requests the Department of Agriculture (Department) to establish a

Sustainable Food Systems Working Group (Working Group). The Working Group is to
be led by the Chairperson of the Board of Agriculture and the Director of the

Department of Planning, Economic Development, and Tourism. The Department offers
comments and has strong concerns.

The Working Group is requested to have 12 members (Page 2, lines 1-36). A single member of the House of Representatives and a single member of the Senate (to be selected by the House Speaker and the Senate President, respectively) are to collaboratively select and invite one representative with knowledge in the following general areas (Page 2, lines 23-36):



- (1) Food as a human right and healthy food for all;
- (2) Social equity and food justice;
- (3) Food system resilience;
- (4) Agriculture and food system sustainability;
- (5) Food at the center of a circular economy;
- (6) Sustainable education, workforce development, and fair labor; and
- (7) Good food governance

The Working Group is requested to develop an "Interagency Food Systems Plan" (Plan) that links to the United Nations "sustainable development goals", identifies a "governance structure", and a plan to implement the Plan.

The Plan and recommendations to implement the Plan are due to the 2025

Legislature. The Department is requested to provide administrative, and staff support to the Working Group and prepare the Plan.

The Department has strong concerns.

The Department is very concerned that there is no request to have agricultural operators or agricultural organizations represented on the Working Group. The Plan risks becoming an academic exercise without the full and sustained participation of local farmers who produce food that most, if not all, of the elements of the Plan will be based on. Further, despite earlier repeated requests by the Department for legislative guidance, there has been no attempt to define each of the seven broad areas that will be at the heart of the Plan. The utility of linking the eleven broad areas to the United

Nations sustainable development goals (Page 3, lines 11-32) is not clear. Further, the Plan is to identify a "governance structure" which is also not defined. (Page 3, line 5)

The Department is requested to "provide administrative and staff support to the Sustainable Food Systems Working Group, including the preparation of the interagency food systems plan" (Page 4, lines 2-4). The Department is very concerned about the duties to the Department in establishing the Working Group, addressing the eleven broad areas, writing the Plan and recommendations for implementation of the Plan to the 2025 Legislature, providing staff support including any meetings that may have to be in accordance with Chapter 92, and writing and printing the Plan. These duties will require the Department to redirect the already severely diminished professional staff resources away from the State's highest priority of increasing the economic viability of existing agricultural businesses and assist in the establishment of new ones in direct support of increasing local food self-sufficiency and export.

The Department is very concerned that the Working Group and the Plan not become an academic exercise with no meaningful impact on the State's highest priorities of increasing the economic viability of existing agricultural businesses and assisting in the establishment of new ones in direct support of increasing local food self-sufficiency and exports.

Aloha Chair Gates, Vice-Chair Kahaloa, and Members of the Committee:

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate and advance the social, economic, and educational interests of our diverse agricultural community.

The Hawai'i Farm Bureau supports SCR 129, SD1, which requests the Department of Agriculture to establish a sustainable food systems working group to develop an interagency food systems plan.

The impacts of the COVID pandemic have highlighted the need to strengthen Hawai'i's food system to ensure greater resilience, food security, human health, and economic diversity and stability.

HFB suggests the following amendments to SCR 129, SD1.

- (1) Extending the date for the Working Group to submit the interagency food systems plan and recommendations to the Legislature from before the 2025 Legislature to before the 2026 Legislature. This extension will provide the Working Group with sufficient time to conduct its activities effectively.
- (2) Amending the date that the Working Group is dissolved from June 30, 2025 to June 30, 2026.
- (3) Authorizing the Co-Chairs, by mutual agreement, to invite additional members to the Working Group as needed.
