A BILL FOR AN ACT

RELATING TO PORT INFRASTRUCTURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that maintenance dredging
- 2 is critical to the maintenance of small boat harbors, channels,
- 3 ramps, and other port infrastructure in the State. The
- 4 legislature further finds that the current system of waiting
- 5 until dredging is imminent to appropriate funds and only then
- 6 initiating the permitting process creates a haphazard system for
- 7 both the allocation of money and the issuance of permits. This
- 8 disorganized process sometimes contributes to worsened
- 9 conditions at these facilities when increased amounts of marine
- 10 sediment and foreign debris accumulate, sometimes up to such a
- 11 height that, if not cleared immediately, can damage the hulls of
- 12 ships. These conditions can potentially cause a shutdown of the
- 13 affected sites, which are important for recreation and
- 14 subsistence fishing and use by the general public, for safety
- 15 reasons.
- 16 The purpose of this Act is to appropriate funds to the
- 17 department of land and natural resources to conduct maintenance

- 1 dredging at state small boat harbors, boat launch ramp
- 2 facilities, and other state boating facilities and waterways,
- 3 including design, permitting, and dredging work, as identified
- 4 by the department of land and natural resources.
- 5 SECTION 2. In accordance with section 9 of article VII of
- 6 the Hawaii State Constitution and sections 37-91 and 37-93,
- 7 Hawaii Revised Statutes, the legislature has determined that the
- 8 appropriations contained in Act 164, Regular Session of 2023,
- 9 and this Act will cause the state general fund expenditure
- 10 ceiling for fiscal year 2024-2025 to be exceeded by
- 11 \$ or per cent. This current declaration takes
- 12 into account general fund appropriations authorized for fiscal
- 13 year 2024-2025 in Act 164, Regular Session of 2023, and this Act
- 14 only. The reasons for exceeding the general fund expenditure
- 15 ceiling are that:
- 16 (1) The appropriation made in this Act is necessary to
- serve the public interest; and
- 18 (2) The appropriation made in this Act meets the needs
- 19 addressed by this Act.
- 20 SECTION 3. There is appropriated out of the general
- 21 revenues of the State of Hawaii the sum of \$3,000,000 or so much

- 1 thereof as may be necessary for fiscal year 2024-2025 for the
- 2 purpose of conducting maintenance dredging at state small boat
- 3 harbors, boat launch ramp facilities, and other state boating
- 4 facilities and waterways, including design, permitting, and
- 5 dredging work, as identified by the department of land and
- 6 natural resources.
- 7 The sum appropriated shall be expended by the department of
- 8 land and natural resources for the purposes of this Act.
- 9 SECTION 4. Beginning with fiscal year 2025-2026 and each
- 10 fiscal year thereafter, the department of land and natural
- 11 resources shall include in its annual budget request line-item
- 12 funding for maintenance dredging at state boating facilities.
- 13 SECTION 5. This Act shall take effect on July 1, 2024.
