SENATE CONCURRENT RESOLUTION

REQUESTING THE DEPARTMENT OF ACCOUNTING AND GENERAL SERVICES TO ESTABLISH A WORKING GROUP TO PLAN AND CONSTRUCT A HAWAII FIRST RESPONDERS MEMORIAL.

WHEREAS, first responders often run toward emergencies and 1 2 disasters as others are fleeing toward safety; and 3 WHEREAS, first responders in Hawaii serve the community 4 courageously and heroically; and 5 6 WHEREAS, the National Fallen Firefighters Memorial in 7 Emmitsburg, Maryland, honors twenty-two firefighters from Hawaii 8 -- twelve from the Honolulu Fire Department, one from the Hawaii 9 Fire Department, one from the Maui County Department of Fire and 10 Public Safety, one from the Kauai Fire Department, one from the 11

12 Division of Forestry and Wildlife of the Department of Land and 13 Natural Resources, three from the Pearl Harbor Naval Base, and 14 three from the Hawaii Firefighters Association; and 15

WHEREAS, according to the United States Fire Administration 16 of the Federal Emergency Management Agency, ten firefighters in 17 Hawaii have died in the line of duty -- four from the Honolulu 18 Fire Department, one from the Hawaii Fire Department, two from 19 the Maui County Department of Fire and Public Safety, one from 20 21 the Kauai Fire Department, one from the Division of Forestry and Wildlife of the Department of Land and Natural Resources, and 22 one from the federal fire department; and 23

25 WHEREAS, six paramedics, two medical flight nurses, and 26 four medical flight pilots from Hawaii have died in the line of 27 duty; and

29 WHEREAS, the National EMS Memorial Foundation seeks to30 establish a permanent National EMS Memorial; and

1 WHEREAS, a similar, appropriate memorial to honor Hawaii 2 first responders should be located in the State; and 3 4 5 WHEREAS, with the construction of a Hawaii First Responders Memorial, the State, along with the families, friends, and loved 6 ones of fallen first responders, will forever honor their lives, 7 which were selflessly given in service to the people of Hawaii; 8 now, therefore, 9 10 BE IT RESOLVED by the Senate of the Thirty-second 11 12 Legislature of the State of Hawaii, Regular Session of 2024, the House of Representatives concurring, that the Department of 13 14 Accounting and General Services is requested to establish a 15 working group to plan and construct a Hawaii First Responders Memorial; and 16 17 18 BE IT FURTHER RESOLVED that the working group is requested 19 to consist of: 20 21 (1) The Comptroller, or the Comptroller's designee, who is 22 requested to serve as chairperson of the working 23 group; 24 25 (2)The fire chiefs of the Honolulu Fire Department, Hawaii Fire Department, Maui County Department of Fire 26 27 and Public Safety, and Kauai Fire Department, or their 28 respective designees; 29 (3) The Chief of Ocean Safety of the City and County of 30 Honolulu, a representative of the Hawaii Fire 31 Department with experience in ocean safety, the Chief 32 33 of the Ocean Safety Bureau of the Maui County Department of Fire and Public Safety, and the head of 34 35 the Ocean Safety Bureau of the Kauai Fire Department, 36 or their respective designees; 37 38 (4) The Director of the Honolulu Emergency Services 39 Department, or the Director's designee; 40 41 (5) A representative of American Medical Response in 42 Hawaii;
