Some Encouraging News:

- Visitor arrivals recovered by 23% in November 2020 and 26% in December in comparison to the same months of 2019.
- Hawai'i bankruptcy filings continued declining.
- Personal income increased 8.2% during the first 9 months 2020 compared with the same period a year ago.
- Initial unemployment claims have been stable at below 5,000 level since October 17.
- Flights from Canada resumed in December, first time since April 2020.



Some Encouraging News (continued)

- Real estate market performing well in terms of resale prices.
- In terms of average daily new COVID-19 cases per 100,000 population, Hawai'i's cases currently ranked the lowest in the nation. Cumulative death rate is also the lowest in the nation.
- COVID-19 vaccine will be widely used by the middle of 2021.
- \$1.7 billion Federal assistance money coming, and the number might be possibly doubled.
- Stock market continues performing well.
- The outlook for U.S. economy has continued to improve since May 2020.




Some Challenging Facts:

- High number of new COVID-19 cases on the U.S. mainland, especially California.
- Increasing new COVID-19 cases in Japan, Korea, and Canada.
- New COVID-19 variant found in California.
- All industries started losing payroll jobs.
- Unemployment rate remains the 2nd highest in the nation.
- Construction activities are slowing down.

7-day average, for week ending December 30, 2020





As of December 30, 2020





(October 15-31 recovery is 16%, November recovery is 23%, December 1-30 recovery is 26% from same month in 2019)











Hawaii Real GDP and Real GET Growth





Hawaii Non-Agriculture Payroll Jobs by Month










Initial Unemployment Claims Below 5K for 10 weeks


