

Impacts of Federal Policies

Positive -- Farmers First (includes Ranchers, Growers)

- Programs that favor PRODUCTION
- America First Hawaii is a STATE address barriers
- Payments DIRECT to farmers and ranchers (small state grant)
- MAHA Opportunities focus on health, nutraceuticals
- Restore the "American Diet" beef, animal proteins, full fat milk

Deglobalization and Slowbalization

- Global economic trade disruptions
- Global election tensions, domestic deficits and distractions
- Climate change no water, fires "everywhere"
- Inflation, recession, food production decreasing
- Social services and support decreasing insecurity "3 meals"

Impact on Farmers and Ranchers

- Hawaii farms decreased 10% from 2017 to 2022
 - o 7,328 to 6,569 (759)
 - Nationally, 2.04 million to 1.90 million a 6.9% decline
- Agriculture relies on farmers and ranchers
 - Farms are on decline global pressures
 - Reliance on imports is not strategic when deglobalization and slowbalization is the trend
