SENATOR FEVELLA ASKS KAISER PERMANENTE EXECUTIVES TO ADDRESS THE UNDERSTAFFING CRISIS OF MENTAL HEALTH CARE SERVICES

Honolulu, Hawai'i – On September 21, Senator Fevella sent a letter to Kaiser Permanente executives on behalf of the 266,000 Kaiser-insured members in Hawai'i and psychologists, social workers, nurses and chemical dependency counselors employed by the company who are currently on strike. In the letter, the senator asked the executives to return to the negotiating table to address the understaffing crisis of Kaiser's mental health care services.

Senator Fevella stated, "The ongoing strike by Kaiser's therapy and mental health clinicians has brought to light the severity of Kaiser's staffing crisis, but it also points to Kaiser's unwillingness to fairly negotiate a resolution when Kaiser's response is to propose a wage freeze and cut retirement benefits, including the climination of pensions for new hires."

While Kaiser has been able to negotiate raises and continue to provide benefits for non-mental health unionized employees, they have continually put negotiations with mental health unionized employees on hold. "It is imperative that Kaiser break through the current stalemate for its members and for those potential skilled therapists in the greater island community who could be available for hire if not for Kaiser's poor working conditions and unsatisfactory compensation scale," wrote the senator.

Due to violations of the national behavioral health standards, Kaiser has been placed under a corrective action plan by the National Committee for Quality Assurances. Senator Fevella suggested using "tried-

SENATE MINORITY LEADER FEVELLA ISSUES STATEMENT AS KAISER MENTAL HEALTH CARE WORKERS ENTER SEVENTH WEEK OF STRIKE

Honolulu, Hawai'i – As Kaiser mental health care workers enter their seventh week of a strike, Senate Minority Leader Kurt Fevella (District 19 - 'Ewa Beach, Ocean Pointe, 'Ewa by Gentry, Iroquois Point, portion of 'Ewa Villages) issued the following statement regarding Kaiser's refusal to reach a fair agreement:

"Kaiser Permanente Mental Health Workers in Hawai'i have been on strike for seven weeks now. As members of the National Union of Health Workers (NUHW), Kaiser's mental health care workers are protesting the severe understaffing of its mental health services.

During the October 5, 2022 rally at the State Capitol, Senator Fevella stated several elected officials and community leaders called on Kaiser officials to do more to improve access to care for its patients who are waiting months to see a Kaiser therapist. The next day Kaiser returned to the bargaining table only to reject NUHW's proposal and offered no further counteroffer to bridge remaining differences between the narties.

Since our rally, Senator Fevella was disappointed to learn that Kaiser has sent an email to private providers with an offer to pay \$5,800 up front for 40 sessions to see five Kaiser patients during an eightweek period. Kaiser's unwillingness to negotiate in good faith and instead pay private providers \$170 person which is more than its typical reimbursement of \$128'session clearly indicates Kaiser officials disregard for its own mental health workers, some of whom have 10 or more years of services at Kaiser Permanente Hawai'i.

Kaiser, which reported a \$8.1 billion net profit in 2021 and \$56.7 billion in cash and investments, would

# HDOT's Plastic Road Pilot





On October 12, 2022, I had the pleasure of meeting with Deputy Director Ed Sniffen of the state's Department of Transportation and his staff to witness the beginning of the plastic road pilot in our 'Ewa Beach community. As mentioned in its published news release-

"The Hawai'i Department of Transportation (HDOT) is testing an asphalt mix with recycled plastic as part of its sustainable transportation initiatives. The plastic road pilot will take place on Fort Weaver Road between Kilaha Street and the beginning of Fort Weaver Road near Cormorant Avenue. The amount of plastic modified asphalt mix used in this pilot—1,950 tons—will keep the equivalent of 195,000 plastic bottles out of the landfill.

As part of the pilot, the University of Hawai'i at Mānoa and Hawai'i Pacific University have been contracted to evaluate the performance of the plastic modified asphalt and the potential of the material to release microplastics into its surroundings. The evaluation period will take place over a year and a half. HDOT will share the results of the evaluation with the public and the legislature.

Fort Weaver Road between North Road and Cormorant Avenue will be paved during the pilot project. The paving began on October 11, 2022, and is expected to be complete in late July 2023, weather permitting.

On September 17, 2022, a candlelight vigil for Ariel Sellers was held at the Waimanalo Gym. Her family members, loved ones, and members of the Kailua community, came together with the purpose of remembering her story. Recalling this past session, HB1932 HD1 SD2 CD12 became law- Act 217, which: 1) requires the Child Welfare Services of the Department of Human Services to develop a modern case management software solution that is compatible with existing child welfare technology; 2) submitting progress reports to the Legislature and; 3) appropriates funds for the development of the modern case management software solution. Although this bill does not resolve all the issues that arose from Ariel's case, I believe it is a steppingstone to what we can prepare for next session as well as with many other potential legislations.
