Kupono Solar Town Hall Presentation

June 15, 2023

- Majority of site preparation has been completed.
- Deliveries of PV racking and modules are nearly finished.
- Trenching for underground electrical and inverter foundations are in motion and racking installations are in progress.
- Foundations for Battery Energy Storage System are underway.
- Ongoing safety audits occur every workday.
- Dust control methods are in place.
- Supported the community via donations such as the wood pallets to JCHS and sponsoring events.
- Environmental efforts: hauled waste and cleaned up ~40,000 lbs. of illegal dumping and recycled ~100,000 lbs. of steel.
- Located multiple honeybee colonies and contacted the local bee farm to relocate for continual pollination.
 - Donated the honey to JCHS Alumni Foundation.

Letter to DLNR

Jet Ski Rule Clarification

Currently, jet skis are not allowed within 500 feet of a shoreline or reef, regardless of use. However, there are no similar restrictions for boats. Those on boats are allowed to fish within 500 feet of a shoreline, but jet skis are not, due to their classification as a thrill craft. We have requested a clarification on the rules regarding jet ski use in early June and have yet, to receive a response.

<u>Enviornmental Assessment for Red Hill</u>
Defueling and Fuel Relocation



An Environmental Assessment (EA) was published in June by the Joint Task Force Red Hill and Defense Logistics Agency. The EA is proposing to relocate the fuel to other Department of Defense (DoD) fuel supply locations in the Pacific region or sell the fuel to commercial entities utilizing DoD contracting authorities. The period for the public to provide comments on the EA was from June 9, 2023 to June 30, 2023. A couple of my remarks included:

- Descriptions of mitigation measures to address potential catastrophic events (spills, accidents, etc.) to be included; and
- Exploring every avenue to retain Hawai'i's resources should be pursued without jeopardizing the health and safety of our people and our resources.

Legislative Update

164 Bills Signed Into Law & 12 Bills For Veto

As of June 30, Governor Josh Green signed several more bills into law- one hundred and sixty-four bills total. Twelve bills have been placed on his veto list, including the "budget bill," HB300 HD1, SD1, CD1. The Legislature must act on any veto by Tuesday, July 11, 2023. SB821 SD1, HD2, CD1 (Act 67) Relating to Fireworks.



Establishes the Illegal Fireworks Task Force within the Department of Law Enforcement to stop the importation of illegal fireworks and explosives into the State, promote compliance with the fireworks control laws, and ensure the safety and security of facilities and institutions in the State against the discharge of illegal fireworks and explosives. Requires reports to the Legislature.



HB579 HD2, SD1, CD1 (Act 83) Relating to Human Trafficking.



Establishes the statewide human trafficking prevention program within the department of the attorney general to provide services and assistance to victims of human trafficking and victims of the commercial sexual exploitation of children. Requires reports to the legislature.



SB295 SD2, HD2, CD1 (Act 86) Relating to Child Welfare Services.



Establishes within the Office of Wellness and Resilience the Malama Ohana Working Group to seek, design, and recommend transformative changes to the State's existing child welfare system. Allows the Office to contract with an administrative facilitator to provide necessary support for the working group. Requires the Malama Ohana Working Group to report to the Legislature.



HB948 HD2, SD2, CD1 (Act 89) Relating to Child and Adolescent Mental Health.



Establishes a two-year child and adolescent crisis mobile outreach team pilot program on Oahu and one neighbor island site to expand existing crisis response services.



SB898 SD2, HD1, CD1 (Act 98) Relating to Kupuna Housing.



Temporarily expands the State Rent Supplement Program specifically for qualified persons who are sixty-two years of age or older and are homeless or at imminent risk of becoming homeless. Requires the Hawai'i Public Housing Authority to submit annual reports to the Legislature.
