JTF-Red Hill Navy Defueling Update

Sen. Kim attended a meeting last week with Navy Adm. Aguilino-- Commander of the U.S. Indo-Pacific Command --- and a small group of Hawaii leaders. We received a final update on Red Hill Defueling ahead of the defueling, which began earlier this week:

- Defueling will be done Mon. through Fri., starting Oct. 16.
- 99% of the fuel (100+M gal) up to the 10 ft. mark will be removed by end of Nov. (about 6 weeks)
- 2M gal. will remain and pumped out by 3rd week in Jan. (7weeks)
- 64,184 gal. (sludge) to be removed by end of April (13 weeks)
- 4,000 gal. residual fuel will remain. Removal will be dealt with as part of the Red Hill closure effort.

The Federal EPA and Hawaii Dept. of Health (DOH) approved the Navy Joint Task Force – Red Hill pre-defueling preparedness report. DOH has conditionally approved the Navy's plan. See: https:// www.epa.gov/newsreleases/epa-approvesjoint-task-force-red-hill-pre-defuelingpreparedness-report

Problem with Feral Chickens?

The Feral Chicken Working Group's first meeting was held on August 17, 2023. We learned that the City is now working with Sandwich Isle Pest Solutions to fund a portion of the cost to private property owners to catch and dispose of feral chickens. The next working group meeting is targeted next month. The working group's membership consist of State and City agencies. They are charged with collaborating on effective ways to address the Feral Chicken issues and submit a report to the Legislature no later than 30 days before the next Legislative Session.

Weatherization Assistance Program (WAP)

WAP is designed to help low-income households reduce their energy consumption and costs. This is achieved through a home energy audit plus household-specific energy efficiency tips and education, and a selection of cost-effective energy efficient measures such as high-efficiency faucet aerators & shower heads, compact fluorescent lighting (CFL) or Light Emitting Diode lighting (LED), and/or an energy-efficient solar water heater, all provided free of charge. The HCAP Weatherization Assistance Program prioritizes services to seniors (60 and older), families with young children (19 and below), people with disabilities, households with high energy usage, and families experiencing a high energy burden.
