Resolution 28-GA-05 supports the establishment of the **Micronesian Center for a Sustainable Future**, an administrative, research and development center for the Western Micronesian Chief Executives' Summit and the Micronesian Presidents' Summit. "Micronesia is seeing a lot of changes in growth, urbanization and Westernization," said Sen. English. "Preserving their culture and resources are vital concerns. Air and Sea Transportation, Aquaculture, Sports and Recreation, Youth and Senior Citizens, Tourism, Finance, Political Status, External Relations, and Development Banking.

BILLS THAT SENATOR ENGLISH INTRODUCED THAT THE 2009 LEGISLATURE PASSED

- SB715** Requires the statewide transportation Council to comply with County transportation plans.
- SB718** Requires State and County transportation departments to accommodate all public highway users.
- SB1055** Authorizes the department of transportation to adopt rules governing commercial harbors.
- SB1056** Conforms penalties to federal law for operating a commercial vehicle with any percent alcohol level.
- SB585** Authorizes pharmacies to dispense medications through controlled remote dispensers.
- SB1202** Establishes a state policy for the development of non-fossil fuel transportation modes.
- SB1223** Specifies the criteria for use of the phrase “made in Hawai’i” and similar phrases.
- SB1676** Clarifies legislative support for expanded use of new technology in tele-health.
- SB415** Requires the department of health to license home care agencies.
- SB423** Appropriations to match federal funds for Medicaid disproportionate share of hospital allowance.
- SB1058** Establishes a task force to examine issues relating to medical cannabis patients and laws.
- SB1664** Adds definitions relating to partial unemployment and sets out claimants’ eligibility.
- SB1665** Enhances Hawai’i’s community colleges’ workforce development.
- SB1673** Authorizes a facility or regional health care system to transition into a new legal entity.
- SB1677** Requires two-thirds majority vote of the legislature to sell or give away public lands.
- SB203** Increases penalties for contractor’s violations.
- SB536** Statewide development of a starlight reserve strategy.
- SB1329** Requires the Dept. of Education to use successful assessment tools to determine a student’s initial placement.
- SB1345** Provides fair compensation when leased public agricultural lands are condemned.

A MESSAGE FROM KALANI

The 2009 legislative session began with our state's economy slowing and tax revenues falling while demands on government services were increasing. Furthermore, over 3,500 bills were introduced in both Chambers. In the end, we passed about 250 bills that take care of the true necessities.
