

In Hawai'i, the GIIP was founded by Dr. Raj Kumar, Ph.D., President- IAFC, Hawai'i Chapter & Founder & President Emeritus GIIP-Gandhi International Institute for Peace, with a mission to provide information, consultation, education, and training to resolve conflict in a non-violent manner. Dr. Kumar's initial efforts resulted in the Hawai'i State Legislature unanimously adopting Senate Bill 332 to designate October 2nd of each year as "Mohandas Karamchand Gandhi Day," a day of recognition and observance. On April 9, 2015, Governor David Ige signed the bill into law as Act 5, making Hawai'i the first state to so honor Gandhi. We're grateful for the efforts of GIIP to serve our state by championing the cause of non-violence and reminding us of the true Aloha Spirit. We wish GIIP continued success in the fulfillment of their mission to honor the legacy of Mahatma Gandhi, while promoting a culture of global peace, tolerance, and understanding.

Hawai'i Tropical Fruit Growers Conference

Kaua'i Site Visits

During the first week of September, I spent time touring various agricultural sites on the North Shore of Kaua'i. As Chair of the Senate Agriculture and Environment Committee, the best part of my job is getting out to meet and talk story with producers across the state. Hearing, seeing, and feeling the

passion in their hearts often brings tears to my eyes. Here's a brief run-down of the sites I visited:

most consistent growers of highquality organic produce and exotic tropical fruit on the Garden Isle. Next stop was Kilauea Community Agricultural Center, 'Aina Ho 'okupu O

Kīlauea, run by Yoshito L'Hote, Executive Director. The Center contributes to island food security and a healthy, stable, balanced local agricultural economy by providing valuable productive agricultural land at low or no cost to farmers; providing low or no cost community garden plots;

run by Ned and Marta Whitlock. Ned and Marta began organic farming on 28.5 acres with a vision of restoring the land and providing their growing family and the people of the Kaua'i with organic food and exotic tropical fruit. In



2002, the land had been fallow for 20 years with a prior history of papaya, pineapple and sugar cane cultivation. In time, the Whitlocks gradually became known by locals and tourists as one of the

operating Kilauea Community Farm, producing produce at low or no cost to community members in need; and, providing a stable, safe, and permanent Farmer Market facility for ongoing direct-to-consumer produce market development. I enjoyed learning about this Center and spending time with Yoshi.

The next day, I visited Kailani

Farms, owned and run by Phil Davies. While walking with

his family in Kilauea after Hurricane Iniki, Phil found a 100-dollar bill which he used to make his first seed purchase. He named his farm after his daughter Sophia Kailani. He started growing a variety of organic greens and vegetables which he sold at a couple of restaurants and farmers markets on the North Shore of Kaua'i. (Continued pg. 3)

(Continued from pg. 2) He eventually decided to focus on salad greens, ginger and turmeric, slowly and steadily growing his business from a few short rows to 30 acres today. Phil now produces greens for many of the restaurants and health food stores on the island. His ginger and turmeric are sold both locally and across the U.S. and Canada. Phil follows Good Agriculture Practices (GAP) and is Certified Organic. He works closely with the Hawaii Farm Bureau, Hawaii Farmers Union United, UH College of Tropical Agriculture, Department of Health, East Kauai Soil and Water Conservation District and Natural Resources Conservation Service to make sure he's involved in all aspects of farm related food safety and strives to grow his crops with the most environmentally friendly, safe and sustainable methods available.

Next was Naaja Organics, founded in 2020 by Angelina McRoberts, who runs this small orchard in Kilauea on a 12-acre parcel of land. Unfortunately, Angelina was dealing with some nasty CRBs (Coconut Rhinoceros Beetles) so we met to discuss possible solutions.

My next stop was Malama Kaua'i. Run by Megan Fox, Executive Director for the past 10 years, Malama Kaua'i is planning to scale its food aggregation and distribution efforts with a new food hub it's building in Moloa'a in partnership with the Moloa'a Irrigation Cooperative, a hui of 70 farms on more than 600 acres. The two-story, \$3M Moloa'a 'Āina Center will have a commercial kitchen, cold storage, processing

equipment and a marketing office. The Cooperative received a grant from the state in 2016 to purchase land to build the food hub. The 3,490-square-foot center will be Admiring Johnny Gordines' flowers at Tropical Flower Express in Kapa'a, Kaua'i's first food hub. What is a food hub, you may ask? Kaua'i, Sept. 4.

Food hubs help small farms by offering а combination of production, distribution, and marketing services. There are an estimated 400 food hubs in the U.S., (14 in Hawai'i) with more Food hubs help connect

producers (farmers and ranchers) with consumers and institutional buyers (restaurants, hospitals, schools...) They help farmers gain access to larger markets so they can focus more on farming and less on marketing, distribution, etc.

The new facility is scheduled to be complete this month.

My next stop on Tuesday was Johnny Gordines' **Tropical** Flower Express in Kapa'a, Kaua'i. Over 25 years ago, Johnny and his wife, Theresa, switched from raising

farm animals to growing flowers on their two-acre farm. They were inspired by their neighbor, Howard Yamamoto, one of the pioneers in raising tropical flowers in Hawai'i, who said that flowers would be the next big thing. Gordines' sells farmers markets farm at and, through Kauaiflowers.com, (continued pg. 4)

Continued from pg. 3.) ships out about 100 boxes a week during busy periods like Christmas, Valentine's Day and Mother's Day. For the past two decades, Gordines has watched the floriculture and nursery products develop into one of Hawai'i's largest ag industries, bringing in \$67.4 million in revenue in 2015.

My last stop was <u>Common Ground</u>, run by Farm Manager, John Parziale. John has practiced organic, ecological agriculture on Kaua'i for 23 years. He's taught permaculture and sustainable agriculture in Hawai'i, the mainland, and Europe. The type of regenerative and ecological agriculture he does is called "successional agro-forestry." This is the integration of crops and animals with trees. Common Ground serves as a lab environment that demonstrates in real time how the farm of the future can look, feel, and taste. This farm blew me away with their agro-forestry project and plans for the future.

Hawai'i State Senate Called into Special Session

On August 21-22, the Hawai'i State Senate confirmed the judicial appointments of Jordon J. Kimura to the Circuit Court of the First Circuit; and Erika E. Ireland, Robert J. Brown, and David M. Hayakawa to the District Court of the First Circuit, State of Hawai'i. The First Circuit is located on the island of O'ahu. All four judges are graduates of the UH Mānoa William S. Richardson School of Law. As the Vice Chair of the Senate Judiciary Committee, I sat on their Committee hearings and feel confident that they'll do a great job.

Jordan J. Kimura has been confirmed to the Circuit Court of the First Circuit, State of Hawai'i. He is currently a co-managing partner at McCorriston Miller Mukai MacKinnon LLP where he focuses on civil litigation and estate planning.

Erika E. Ireland has been confirmed to the District Court of the First Circuit after serving as a Per Diem Judge to the same court for two years.

Robert J. Brown has been confirmed to the District Court of the First Circuit. He has been employed as a civil litigation associate with Starn O'Toole Marcus & Fisher since 2018, and also serves as a Per Diem Judge for the Family Court of the First Circuit.

David M. Hayakawa has been confirmed to the District Court

of the First Circuit. Since 2012, he has managed his own criminal defense law practice, the Law Office of David Hayakawa. Judge Hayakawa also has experience in family law and serving as a deputy public defender for the Office of the Public Defender for the State of Hawai'i.
