## A Fresh Start for the New Year

"The Roaring 2020's" are upon us with the start of the new year and legislative session. I am honored to continue as your State Senator for the Fourth District of Hawai'i Island.

I am supporting the Joint House-Senate Economic bills which cover the following topics:

- Targeting tax relief for working class families and individuals,
- Increasing the minimum wage,
- Developing leasehold housing for the working class,
- Providing tax exemptions for developers to build market priced homes,
- Providing infrastructure for developments at or near rail stations,
- Expanding childcare options for parents near their workplaces,
- Creating a new Schools Facilities Agency and allow DOE to focus on education.

Some of the bills I introduced this session address safety on island roadways including the creation of a red light camera system and a reduction to the blood alcohol count applied to drivers operating a motor vehicle under the influence. I introduced legislation to obtain capital improvement projects (CIP) for the Fourth Senatorial District, create affordable rental housing in Honokaa, and get much needed improvements to the Banyan Drive area in Hilo. I was honored to present Senate Certificates to **Carol Okada** and **Dr. Haruyuki Kamemoto** as recipients of the 2019 HFNA/ HFSA Shinnenkai Award presented in Hilo on January 11.

I attended the dedication of the Queen's Medical Center North Hawaii Community Hospital's new emergency room which held an open house for the public on Saturday, January 25 in Waimea. The new facility is 13,000 square feet large and houses 13 new beds. The old E.R. will be converted to administrative offices. Met up with hospital officials Wayne Higaki, Dr. Gary Goldberg, Cindy Kamikawa, Jill Hoggard Green, Rowena Buffett Timms and others at the open house event.

The Hawaii State Health Department is not recommending any travel to China at this time since the outbreak of the **Novel Cornavirus**. The Daniel K. Inouye Honolulu International Airport started screening passengers from China for the coronavirus. It is one of 20 airports nationwide that are screening for it. Direct flights from China have been suspended by airlines serving the Hawaii market. The state will continue monitoring.

Hawaii State Senators and Representatives along with other employees at the State Capitol gathered to honor fallen Honolulu Police Officer **Tiffany Enriques** as her funeral motorcade made its way for a salute at HPD headquarters in Honolulu.

The Hawaii Airports Corporation Bill (**SB 666**) is a carry-over bill from last year which is currently in the House Finance Committee awaiting a date for a hearing and passage. Speaking of airports, **Southwest Airlines** started service to Hilo International Airport on January 21 and expanded flights into Kona.

# Nine Bills That Became Law in 2019

Nine bills that I introduced during the 2019 session became law last year. They include the following:

Act 006 / SB 512 – DOT Appropriation; Harbors Division \$40 million

**Act 031 / SB 1378** – Certificates of Registration exemption for owners of chassis for shipping containers.

Act 131 / SB 663 – Establishes within the DOT a red-light running committee to develop policy for county pilot programs.

Act 143 / SB 661 – Grants procurement priority for fuel cell electric vehicles for state and country purchases.

Act 159 / SB 1091 – Emergency Appropriation to DOT for landslide repair to Pali and Honoapiilani Highways. Bill originally introduced as a CIP for highways division.

Act 175 / SB 1037 – Domestic Violence; Abuse of a Family Member; Strangulation; Bodily Injury

Act 220 / SB 411 - Vehicle Safety Inspections; Registration; License Requirements; Marine Terminal Equipment

Act 233 / SB 660 – Non-compliant Identification Card option for those who are severely disabled.

Act 280 / SB 409 – Annual vehicle registration surcharge fee for EV and alternative fuel vehicles

# Funding Released for District 4 Capital Improvement Projects

Senator **Lorraine R. Inouye** announced a number of Capital Improvement Projects for schools, a health center, and airport that were released by Governor **David Ige**.

A total of \$800,000 in General Obligation bond funding was made available for the **Hāmākua Health Center, Inc.**, for phase 1 of their new health center

The Ellison Onizuka Kona International Airport will receive \$8 million for a USDA Inspection Building, and \$32.4 million for an Aircraft Rescue Fire Fighting (ARFF) Regional Training Facility. Earlier this year, the Governor also released \$2 million for ramp and taxiway improvements for the airport.

Several schools received funding as well. The Governor released \$2 million for a covered playcourt at **Jonah Kūhiō Kalaniana'ole Elementary and Intermediate School**, and \$3.6 million for a covered playcourt at **Kohala Middle School**.

A total of \$400,000 will be used for renovations to the Home Economics classroom at **Pa'auilo Elementary and Intermediate School.** 

"I am very pleased that Governor Ige released funding for these much-needed resources for Hāmākua Health Center, district schools, and the airport in Kona," said Senator Inouye.

### **2020 Election Will Be By Mail**

Starting this year all registered voters will be voting by mail. Registered voters will be receiving a mail ballot packet about 18 days prior to the Primary and General Elections.

Those who have moved, or are new to the election process need to go to the Office of Elections website to get more information and fill out online forms to update your voting status.
