





## **CIP- District 2**

- HWY130 Improvements
  - ▶ FY22: \$1,300,00
  - FY23: \$36,500,000
- \$2.5 Mil Keaau High Swimming Pool
- \$10 mil- Keaau Library design & construction
- \$18 Mil 4-Mile creek bridge to expand to 2 lanes instead of 1 between Hilo and Puna

### Earned Income Tax Credit (EITC)



HB2510

 Makes the state earned income tax credit refundable and permanent. Provides for carryforward of nonrefundable credits previously claimed.
 Incrementally increases the minimum wage and tip credit beginning on 10/1/2022.

### Department of Hawaiian Homelands



#### ► HB2511

Provides \$600 Mil to the Department of Hawaiian Home Lands.

#### Minimum Wage Increase



#### ▶ HB2510

- Increases the minimum wage:
  - ▶ By 2022: \$12
  - ▶ By 2024: \$14
  - ▶ By 2026: \$16
  - ▶ By 2028: \$18

### Kupuna Driver's License



SB2679

Extends the renewal period from two years to four years for licensees who are seventy-two years of age or older but younger than eighty years of age.

### **Keiki Protections**



#### ► HB2424

- Strengthen the State's oversight of children who were previously in the foster care system and were subsequently adopted.
- \$8 Mil towards hiring and retaining social workers; Vetting, training & supporting foster parents.
- \$5 Mil + towards Family First programs and Family Resource Center.
- \$100 Mil towards early learning and child care supports like wage subsidy for workers, increasing more child care.
- \$4.5 Mil towards child wellness incentives.

#### Safe Spaces for Youth



#### **SB3235**

Establishes the Safe Spaces for Youth Pilot Program.

#### Homelessness - Ohana Zones



#### ► HB2512

Extends the sunset date for the ohana zones pilot program to 6/30/2026 and appropriates \$15 Mil for purposes of helping homeless individuals and families transition into permanent housing.

### Subdivision Roads



#### > SB3324

Establishes a working group to examine and address the problem of infrastructure repair and maintenance in planned housing subdivisions that do not have compulsory homeowner associations.

## **Working Families**

**SB2857:** Child wellness incentive pilot program that pays \$50 to each state Medicaid benefit recipient for each completed well-child examination.

**SB3110:** Authorizes the childcare grant program special fund to be used to give grants to childcare facilities. Federal Childcare Grants of \$80 million to support caregivers.

SB514: Provides tax rebates of \$100-\$300 per family.

# **Crime**

HB1413 and HB1414: Abandoned vehicles; Makes owner responsible for abandoned vehicles.

HB2169: Assists safe reentry and reduces recidivism.

HB2309: Enhances offender diversion programs and strengthens community-based reentry and rehabilitation programs.

## Crime (cont.)

HB1486: Increases theft of a motorcycle or car to a class B felony.

HB1455: Amends the offense of robbery in the first degree to include a person committing theft or unlawful taking of a motor vehicle while being armed with an electric gun.

**HB2422:** Requires Domestic Violence intervention for all Family Abuse Cases.

SB2279: Catalytic Converter theft bill. increases regulations regarding the sale of catalytic converters, and subjects persons who violate these provisions to a class C felony.

## **Resolutions:**

**SR173:** Urging the Department of Human Services to designate two fulltime employees to assist Compact of Free Association Migrants to enroll in Medicaid.

SR146: A study on establishing a Ka'ū senior living center.

**SR147:** Needs assessment for Ka'ū urgent care and behavioral health services.

**SR144:** A study on the establishment of a Ka'ū Family Guidance Center Office.
