## DECEMBER 2025 LEGISLATIVE UPDATES

Aloha:

As we move closer to the opening of the 2026 Legislative session, I would like to thank everyone for your continued engagement throughout the interim. Due to federal developments outside of our control, the 2025 interim was especially busy. As Chair of the Senate Committee on Health & Human Services, I held informational briefings related to the Federal Shutdown's effects on SNAP recipients, the status of Medicaid (QUEST Integration) in Hawai'i following passage of the OBBB Act, updates on the Hawai'i State Department of Health (DOH) Adult Mental Health Division and the Hawai'i State Hospital (HSH) overcrowding, and the DOH Deposit Beverage Container Program failures.

Despite the challenges and the continual changes at the federal level, we at the Hawaii State Legislature passed a number of bills to help lesson the economic hardship on many struggling local families. To prepare for more expected federal funding cuts, I am already working on bills to safeguard support programs that benefit local families and mitigate the fiscal strain on state taxpayers. I have also been encouraging state agencies to be proactive in identifying and leveraging funding sources that would help our state to administer benefits in the event of another federal shutdown.

# 2026 GRANT-IN-AID

The Hawaii State Legislature announces that the Grant-In-Aid (GIA) process for the 2026 Legislative Session is now open, and eligible organizations are asked to submit their applications to the legislature.

The Legislature will continue to accept GIA applications until Friday, January 23, 2026, at 4:30 p.m., and final determinations will be made as Council on Revenue forecasts in January and March are published.

The Legislature makes appropriations for GIA in accordance with Chapter 42F of the Hawai'i Revised Statutes (HRS). The Eligibility Verification stage requires the submission of documentation to verify that the Grantee meets the standards for a grant award under HRS §42F-103.

## INFORMATIONAL BRIEFING: SNAP CONTINGENCY PLANS

I held a public informational briefing to receive updates from the Department of Human Services (DHS) regarding the impact of the current Federal Government Shutdown on the Supplemental Nutrition Assistance Program (SNAP) in Hawai'i and to review the state's contingency plan to ensure food security for affected residents. At a recent press conference, Governor Green credited my info briefing for the launch of the Emergency Hawaii Relief Program. I appreciate the Governor's quick action and will continue to work with both state and non-profits to minimize the impact of the shutdown. # INFORMATIONAL BRIEFING: MEDQUEST & OBBBA

On December 19th, I held a joint Informational Briefing with the Senate Committee on Commerce & Consumer Protection to receive a report from the Department of Human Services (DHS) Med-QUEST Division on the status of Medicaid (QUEST Integration) in Hawai'i, specifically addressing the recent and impactful federal policy changes. The agenda focused on the status of the Post-COVID medicaid unwinding process, analyzing Hawai'i's eligibility redetermination progress and disenrollment rates. Discussion covered federal policy changes from legislation like the OBBBA of 2025, which introduced administrative burdens and increased eligibility checks that are projected to cause significant disenrollment. The briefing examined the correlations with disenrollment and ACA marketplace transition, focusing on the process of moving ineligible individuals to the marketplace, their qualification for ACA Premium Tax Credits (APTCs), and the potential severe consequences from the scheduled expiration of enhanced APTCs at the end of 2025. Max 6% of residents will potentially be uninsured which means higher premiums for the insured and physicians/med centers not getting paid.

The briefing included presentations from: Kaiser, HMSA, and AlohaCare, and two Federally Qualified Health Centers (FQHC): Waianae Coast Comprehensive Health Center (WCCHC), and Hawaii Island Comprehensive Health Center (HICHC). The briefing concluded with a presentation from HealthCare Association of Hawaii (HAH). The recorded session has been archived for public viewing on the Hawai'i State Senate YouTube channel.

Request copies of police reports for legal, personal, or insurance purposes.

Provide confidential information to assist investigations.



# KNOW YOUR RIGHTS: TELEMARKETING SALES RULE

Did you know that the Federal Trade Commission (FTC) established the Telemarketing Sales Rule (TSR), a federal law to protect consumers from unwanted or deceptive sales calls? Here are three core protections you're entitled to:



**1**

**Disclosures:** By law, telemarketers must clearly identify who they are, the company they represent, and the purpose of the call. Legally, they cannot mislead you about their identity, the product or service, or your options.

**2**

**Call Time Restrictions:** Under the TSR, telemarketers are only allowed to call during reasonable hours — typically between 8 a.m. and 9 p.m. in your time zone — unless you've given them permission to call at other times.

**3**

**Do Not Call Registry:** If your number is on the National Do Not Call Registry, most telemarketing sales calls are illegal. Telemarketers may only call you if you've given prior consent or have an existing business relationship. Violating this law can result in federal penalties.





# SCAM ALERT: MEDICARE



*Scammers are exploiting the Medicare open enrollment period by pretending to be from Medicare and asking you to "update" or provide "new information" for your Medicare card. Their goal is to steal your personal and financial details. Here's how to keep safe from these scams:*



## Ignore unexpected calls

Caller ID can be faked. If you receive an unexpected call claiming to be from Medicare, asking you for your personal information, hang up and call 1-800-MEDICARE directly (1-800-633-4227).



## Get help comparing coverage options

Contact the Hawaii Insurance Division, the Hawaii State Health Insurance Assistance Program (SHIP), or visit Medicare.gov for a reliable source of official Medicare information and trusted guidance.



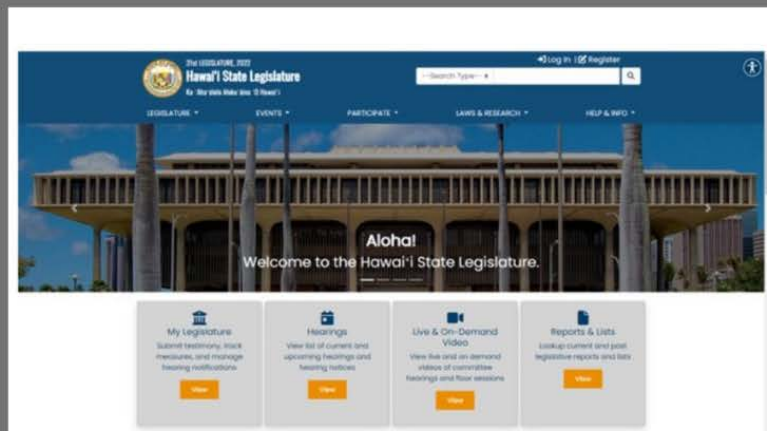
