# **Bills Introduced by Senator DeCoite**

### **SB2498-RELATING TO FINANCING (CESSPOOLS)**

Establishes the Cesspool Conversion Revolving Loan Fund and directs green energy market securitization loan repayments and interest to be deposited into the Cesspool Conversion Revolving Loan Fund. Requires the Hawai'i Green Infrastructure Authority to administer the Cesspool Conversion Revolving Loan Fund. Requires a report to the Legislature. Makes an appropriation.

### **SB2543**-RELATING TO SEARCH AND RESCUE

Requires government entities to seek reimbursement for search and rescue expenses from persons who require rescue after ignoring warning signs, leaving a hiking trail to enter a prohibited area, or hiking on a trail closed to the public

### **SB2539**-RELATING TO RENEWABLE ENERGY

Requires government entities in the State that issue building permits to implement SolarAPP+ or a functionally equivalent online automated permitting platform that verifies code compliance and issues permits to licensed contractors for solar distributed energy resource systems in real-time by 1/1/2025. Requires government entities in the State that issue building permits in areas served by an investor-owned electric utility to adopt a self-certification process for solar distributed energy resource systems that are not SolarAPP+ compatible.


### SB2771-RELATING TO EMERGENCY MANAGEMENT

Requires the Hawai'i Emergency Management Agency, in collaboration with the county emergency management agencies, to conduct a study researching the effectiveness of using distinct sounds or tones emitted by outdoor warning sirens to warn the public of different types of emergencies and indicate whether evacuation is necessary. Requires a report to the Legislature before the 2025 Regular Session.

# **SB3265-RELATING TO FILM INDUSTRY DEVELOPMENT**

Establishes the Hawai'i Film Advisory Council. Amends the motion picture, digital media, and film production income tax credit to increase the annual cap to \$60,000,000; extend the sunset date of the tax credit to January 1, 2039; clarify and amend the requirement for an independent third-party certification; and expand the definition of "qualified production" to include streaming platforms. Provides a tax exemption for certified development of film studio facilities. Establishes one full-time equivalent (1.0 FTE) film industry development liaison within the Creative Industries Division of the Department of Business, Economic Development, and Tourism. Declares that the general fund expenditure ceiling is exceeded. Makes an appropriation.

# **Important Legislative Deadlines**

Mar 7- FIRST CROSSOVER (BILLS)- Deadline for bills to pass third reading in order to move (or "crossover") to the other chamber. If successful, House bills are sent to the Senate and Senate bills are sent to the House for further consideration

Mar 8-LAST DAY TO INTRODUCE SUBSTANTIVE RESOLUTIONS - Concurrent resolutions (HCRs and SCRs) require adoption in each chamber and are used to state the official position of the Legislature on an issue, or to request action formally without having to mandate it by law. They require only one vote in each chamber for adoption, and do not enroll to the Governor

Apr 5- SECOND DECKING (BILLS)-Deadline for bills that have been amended by the non-originating chamber to emerge from all their committees (with committee reports filed) and be submitted to the clerk of that chamber. This "decking" ensures a mandatory 48-hour opportunity for final review by the non-originating chamber's members before third reading (Note: House Bills with only a single referral need to be filed by the committee by April 5)

APR 11 -SECOND CROSSOVER (BILLS)- Deadline for bills to pass third reading in their non-originating chamber and to "cross back" to the originating chamber

APR 25-FINAL OF NON-FISCAL BILLS - Deadline for submitting non-fiscal bills for final reading by both chambers

APR 26 - FINAL DECKING OF FISCAL BILLS - Deadline for submitting fiscal bills for final reading by both chambers. Fiscal bills include appropriation of spending bills, tax credits, etc., or any bill with a House Finance (FIN) or Senate Ways and Means (WAM) referral.

MAY 3-ADJOURNMENT SINE DIE - The end of session is the deadline for Final Reading of bills and adoption of resolutions. Adjournment sine die occurs on the last day of a Regular Session and indicates a suspension of the business of the legislature indefinitely. Next, the Legislature will certify the bills whose form both chambers have agreed to and will transmit or "enroll" those bills to the Governor.
