Stay-at-home order extended to May 31st

The statewide stay-at-home order has been extended to May 31st. However, the Governor has announced that there will be consideration of allowing **some activities** and businesses to resume throughout the month of May. Thorough hygiene, social distancing and wearing face masks will still be required.

As of the time of this newsletter going to print, the list of re-openings included landscapers, florists, astronomical observatories, auto dealers (by appointment), pet grooming (by appointment), car washes, real estate showings (by appointment), retail stores and shopping malls (pickup and delivery encouraged), non-profit organizations, and wholesale & warehousing businesses.

The good news is that the efforts that have been made over the last several weeks have been successful in preventing further spread of COVID-19. Mahalo for your kokua!

Unemployment Insurance/PUA

With tourism at a standstill and many businesses closed, the number of unemployment claims has skyrocketed and the UI system has been overwhelmed. Work is ongoing to improve the system. We deeply regret that many of you have been unable to get through on the phone or website to file claims and have had to experience so much frustration to be able to access your benefits. You will still be covered from your date of eligibility, even if you have had trouble accessing the system to file on time.

Small Business Assistance

Health Insurance

- ⇒ If you recently lost health insurance through your employer, you may be eligible for **Med-QUEST**. To determine your eligibility or to apply for benefits, visit <u>medical.mybenefits.hawaii.gov</u>.
- ⇒ You may qualify for **special enrollment through the ACA** due to recent unemployment or loss of employment-based health insurance due to COVID-19. Apply online at <u>HealthCare.gov</u> or call 1-(800) 318-2596.

Driver's Licenses, Safety Checks, Registration

- ⇒ Deadline to obtain a Goldstar Real ID has been extended to October 1, 2021: tsa.gov/coronavirus
- ⇒ **Driver's licenses or State IDs** that expire between March 15th and May 31st will be valid for an additional 90 days past their expiration date.
- ⇒ **Safety checks** that expire on or before May 31st will be valid until August 31, 2020. All other safety checks that expire in 2020 will be valid for an additional 3 months after expiration.
- ⇒ **Vehicle registrations** can still be renewed via mail, at the DMV kiosk at Kona Safeway, and online at mvr.ehawaii.gov/renewals/lookup.html?county=hawaii.

Student and Family Resources

Schools will remain closed for the rest of the school year, and we encourage parents and students to check the DOE website at hawaiipublicschools.org for updates from the Department of Education (DOE).

- ⇒ Details about **alternative graduation ceremonies** for the class of 2020 will posted on the DOE website at <u>hawaiipublicschools.org.</u>
- ⇒ DOE has created a **resource hub** at <u>bit.ly/HIDOEVirtualLearningParentResource</u> to provide support for parents and students of all ages.
- ⇒ The Hawaii State **Public Library System** has digital resources that students can access. Visit <u>librarieshawaii.org</u>.
- ⇒ The **Executive Office on Early Learning** has created a resource list with subsidy information and activities for young children at <u>sites.google.com/eoel.hawaii.gov/covid-</u>19/home.



Rents, Mortgages & Eviction Moratorium

- ⇒ The Governor has issued a **moratorium on any residential evictions** for non-payment through May 31st. More info at: <u>cca.hawaii.gov/ocp/landlord-tenant-faqs</u>.
- ⇒ Homeowners with **federally-backed mortgages may be eligible for a suspension** on payments, and should contact their mortgage servicer to ask. Homeowners with privately help mortgages who are experiencing difficulty making payments are advised to contact their mortgage servicer to discuss options.
- ⇒ The Hawaiian Homes Commission authorized emergency **postponement of DHHL mortgage payments.** For more information, call (808) 620-9500.

Food and Meals Assistance

- ⇒ The Hawaii Department of education continues to offer free **DOE grab-and-go breakfast** and lunch service for children under 18 on weekdays. Visit hawaiipublicschools.org for more info and an up-to-date list of locations.
- ⇒ **The Food Basket** is offering assistance to those who need. Visit <u>hawaiifoodbasket.org</u> for a full list of sites.
- ⇒ You may be eligible for the **Supplemental Nutrition Assistance Program** (SNAP) benefits (aka food stamps). To determine eligibility and for application instructions, visit humanservices.hawaii.gov/bessd/snap.

Continuity of Utility Services

- ⇒ **Hawaiian Electric** has suspended any service disconnections through June 30, 2020. If you are experiencing financial hardship due to COVID-19, contact HELCO to discuss payment options at (808) 329-3584.
- ⇒ **Dept. of Water Supply** will not disconnect service during this crisis. Through May 31st, DWS will only accept payment by phone, online, auto-pay, or mail. Visit hawaiidws.org to pay online, or call (844) 216-1994.
