





HOUSING & HOMELESSNESS HB 1630

Stops county zoning laws from preventing residential lots in urban districts from having four or more residential units

HB 1834

Provides more money to increase the Department of Human Services' homeless programs office budget.

HB 1833

Provides more money for the Rental Housing Revolving Fund, which helps pay for mixed income rental projects or units in mixed-income rental projects for qualifying individuals and families.

RECRUITMENT & RETENTION OF PUBLIC WORKERS HB 1832

Allows state departments, agencies, or divisions, other than the Department of Human Resources Development, to conduct minimum qualifications reviews of applicants for vacant positions within that respected state department, agency, or division.

HB 1947

Reduces the minimum number of years of service from ten to five years that State and County employees, who became members of the employee's retirement system after June 30, 2012, must have to be eligible for benefit status for retirement allowance purposes.

MENTAL HEALTH

HB 1831

Creates and provides money for the behavioral health crisis center pilot program.

HB 1830

Establishes provisional or associate level licensure requirements for marriage and family therapists, mental health counselors, and psychologists and allows insurance reimbursements in some circumstances.

HEALTHCARE DELIVERY HB 1827

Provides money to the Department of Labor and Industrial Relations and Department of Education to support the public school healthcare workforce certificate program and glidepath program for nurse aides, and renovate certain public school classrooms to be used for healthcare training.

FOOD & SUPPLIES HB 1836

Allows pharmacists, during states of emergency, to refill prescriptions of up to thirty-day supplies of dangerous drugs or devices if the prescriber cannot be contacted for authorization and the pharmacist believes the patient's well-being will be significantly threatened without the prescription.

SHELTERS HB 1838

Allows counties to create zoning laws that phase out nonconforming single-family transient vacation rental units over a reasonable period of time.

HCR NO.3

BIPARTISAN MAUI WILDFIRE WORKING GROUP RECOMMENDATIONS

M

Urges all Counties to establish an emergency zoning code that would allow for the establishment of temporary shelters and prefab housing, and work with the State Land Use Commission to identify appropriate lands in urban growth areas.

ENVIRONMENTAL REMEDIATION HB 1839

Provides money for the long-term monitoring of air and water quality for communities impacted by the Maui wildfires, as well as supports research to better understand the environmental concerns linked to urban fires.

HB 1840

Provides money for the Department of Land and Natural Resources to support long-term water quality monitoring and pollution source detection.

WILDFIRE PREVENTION HB 1841

Provides money to the Department of Land and Natural Resources for operating expenses, equipment, the establishment of positions, and capital improvement projects to support wildfire emergency response.

HB 1842

Increases the maximum fine for violations of fire protection laws, specifies that each day a violation of the fire law exists constitutes a separate offense, and raises the criminal penalty for the offense of arson if the violation is closely associated to an area a red flag warning is in effect.

HB 1843


Provides money and establishes the Office of the State Fire Marshal to direct fire protection efforts statewide.
