Senator Laura H. Thielen Senate District 25: Kailua, Waimanalo, and Hawaii Kai




Aloha Neighbors,

First Crossover Survey Results



Shall a program be established to facilitate the development of low-cost homes, which are available only to Hawaii residents who don't own any other residential property, as leasehold sales on state land near rail stations?


Answer	Senate	Responses
Yes	24	57
Yes, with reservations	1	60
No	0	27

I voted yes because we need more homes for Hawaii residents - we have the lowest percentage of homeowners in the nation. Residents who have no choice but renting are stuck in a cycle of rising rents, no mortgage deduction, and often having to disrupt their families when they are forced to move.

Shall an adult survivor of child sexual abuse be allowed to bring a lawsuit for civil damages against the perpetrator at any time? (Eliminates the statute of limitations on civil actions for sexual abuse of a child)


Answer	Senate	Responses
Yes	23	76
Yes, with reservations	0	37
No	0	31

I voted yes. Child victims of abuse often suppress memories. These can surface later in life when, as adults, they have children of their own. They should have the ability to bring an action seeking civil damages.


First Crossover Survey Results




Shall a "carbon tax" be issued on products that emit carbon (eliminating the gas tax, and replacing it with a carbon tax)?

Answer	Senate	Responses
Yes	20	49
Yes, with reservations	4	42
No	0	46

I voted yes, even though this bill needs more discussion and more work. I wanted the bill to move forward to have more hearings, bring some UH economists to the table, and find ways to tax activity that generates harmful pollution in order to discourage it, and encourage more renewable energy.





Shall pedestrians be allowed to enter the crosswalk during the flashing countdown timer, so long as they finish crossing the street before the timer ends?

Answer	Senate	Responses
Yes	20	86
Yes, with reservations	3	30
No	0	31

I voted yes on third reading. I completely support allowing pedestrians to start crossing the street during the countdown so long as there's time for them to get to the other side before the light turns to the red flashing signal.

Shall the minimum wage be incrementally increased to \$15 per hour by 2023, provided that there is a tax credit for small businesses – fewer than 50 employees – to help offset the increased cost of wages?

Answer	Senate	Responses
Yes	18	91
Yes, with reservations	5	29
No	1	27

I voted yes. The bill phases increases over time, and also provided some relief to small businesses based on number of employees. This is a fair compromise.
