Sen. Malama Solomon's Votes No on Senate Bill 286 SD 1

Here We Go Again: Hawai'i Island/ Neighbor Islands Iced Out

Honolulu –Senate Bill 286 Senate Draft 1, Relating to Reapportionment, reinstates the definition to include the military and their dependents in the population data which will be used in 2020 to determine redistricting. "I was one of the four plaintiffs in Solomon v. Abercrombie, 126 Haw. 283, 270 P.3d 1013 (2012), who were successful in proceedings before the State Supreme Court on the reapportioning of the State Senate to add a fourth State Senate seat to the County of Hawaii and overturned this decision."

## Governor Releases \$18.5 Million for Airports and Harbors on Hawaii Island

**HONOLULU** – Hawaii Island airports and harbors have received \$10.7 million for various capital improvement projects (CIP). The funds are part of the \$113 million CIP package for various statewide projects that Governor Neil Abercrombie released earlier this week. University of Hawaii Board of Regents approved \$9 Million for Hawaii Community College's Palamanui campus' Phase I project.
