Dear Madam President and Members of the Senate:

Re: House Bill No. 777 HD2 SD2 CD1

On July 10, 2007, House Bill No. 777, entitled "A Bill for an Act Relating to the Hawaii Educator Loan Program" became law without my signature, pursuant to Section 16 of Article III of the Constitution of the State of Hawaii.

The bill makes changes to the Hawaii Educator Loan Program administered by the University of Hawaii and appropriates \$250,000 in general funds to the University for the program.

I am a strong supporter of the Hawaii Educator Loan Program and believe it is a tool we can utilize to increase the number of qualified teachers in Hawaii. That is why I introduced House Bill No. 2350 and Senate Bill No. 2313 in 2006, to provide program and funding support to the Hawaii Educator Loan Program. However, this bill does not adopt the programmatic changes that would increase the number of qualified teachers in Hawaii.

Recipients of the Hawaii Educator Loan Program should be allowed to attend any State approved teacher education program approved by the Hawaii Teacher Standards Board, not just the University of Hawaii. Other Hawaii colleges who have State approved teacher education programs include Brigham Young University – Hawaii, Chaminade University of Hawaii, Hawaii Pacific University, and the University of Phoenix – Hawaii. However, the students who attend these schools cannot qualify for the Hawaii Educator Loan Program. Further, recipients of the program should be able to teach in charter schools.

I am hopeful that the Legislature will come back next year and make these needed changes to the Hawaii Educator Loan Program in order to increase the number of qualified teachers in Hawaii.

# A BILL FOR AN ACT

RELATING TO THE HAWAII EDUCATOR LOAN PROGRAM.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1       SECTION 1. In 2001, the Hawaii educator loan program and  
2 special fund were established to recruit college students to  
3 become educators and to ensure that these graduates teach in our  
4 public schools. The legislature finds that although the program  
5 has proven to be successful, the State is still experiencing a  
6 teacher shortage. In particular, hard-to-fill positions,  
7 including special education, regular education shortage  
8 categories, and teacher positions in rural areas have posed a  
9 significant teacher recruitment and retention challenge for our  
10 public schools.

11       The purpose of this Act is to expand the Hawaii educator  
12 loan program to recruit and retain qualified teachers to teach  
13 in public schools located in rural areas throughout the State.

14       SECTION 2. Section 304A-701, Hawaii Revised Statutes, is  
15 amended to read as follows:

16       "~~§~~304A-701~~§~~ Hawaii educator loans; eligibility;  
17 amounts~~[-]~~; educator loan forgiveness program; repayment;

18 collection. (a) There is created the Hawaii educator loan



1 program to be administered by the University of Hawaii, in  
2 partnership with a financial institution whose operations are  
3 principally conducted in Hawaii, to provide financial support to  
4 students and teachers who complete a state-approved teacher  
5 education program and who agree to teach as a full-time teacher  
6 for a period of time to be determined by the University prior to  
7 the award of a loan, in [the]:

8 (1) The Hawaii public school system[+] in a hard-to-fill  
9 position including special education, regular  
10 education shortage categories, or Title 1 schools, and  
11 in one of the following capacities:

12 (A) As an elementary school teacher teaching in the  
13 field of elementary education who has met  
14 standards as set forth by the Hawaii teacher  
15 standards board; or

16 (B) As a secondary school teacher teaching in the  
17 subject area that is relevant to the loan  
18 recipient's academic major as certified by the  
19 department of education who has met standards as  
20 set forth by the Hawaii teacher standards board;  
21 or

22 (2) At a school located in a rural area in the State, as



1 determined by the superintendent of education.

2 Eligibility shall be [~~awarded~~] determined by the university [~~to~~  
3 ~~students~~] on a competitive basis. The amount to be loaned to a  
4 student shall be determined by the board of regents based on  
5 need for financial aid and proof of acceptance into a state-  
6 approved teacher education program at the [~~university.~~]

7 University. The maximum amount of loans that a student may  
8 receive under this program shall be an aggregate amount  
9 equivalent to tuition payments and costs of textbooks and other  
10 instructional materials necessary to complete a state-approved  
11 teacher education program.

12 (b) All loans made under this subpart shall bear interest  
13 at five per cent simple interest. Repayment of principal and  
14 interest charges shall commence one year after graduation or  
15 three months after a loan recipient ceases to be enrolled in a  
16 state-approved teacher education program and shall be paid in  
17 periodic installments within a seven-year period. The  
18 University may charge late fees and all other reasonable costs  
19 for the collection of delinquent loans.

20 (c) The University shall adopt rules to implement the  
21 educator loan program. The rules shall be adopted pursuant to



1 chapter 91, but shall be exempt from the public notice and  
2 public hearing requirements.

3 (d) Liability for repayment of a loan shall be canceled  
4 upon the death or permanent total disability of the borrower.

5 (e) Upon a showing of proof that the loan recipient has  
6 completed a state-approved teacher education program and for  
7 each year that the loan award recipient teaches in the Hawaii  
8 public school system pursuant to subsection (a)(1) or (2), loan  
9 forgiveness shall be provided to the recipient as follows:

10 (1) Ten per cent of the total amount of the loan award and  
11 interest shall be waived every year for the first five  
12 years of repayment; and

13 (2) Twenty-five per cent of the total amount of the loan  
14 award and interest shall be waived every year for the  
15 sixth and seventh years of repayment.

16 (f) If a loan recipient who is a graduate of a state-  
17 approved teacher education program subject to this section and  
18 teaching pursuant to subsection (a) fails to teach in the Hawaii  
19 public school system for the minimum number of years, as  
20 determined by the University prior to the loan, from the  
21 recipient's original date of employment with the department of  
22 education, excluding temporary leaves of absence, then the



1 recipient shall repay any remaining loan balance at the rate of  
2 ten per cent simple interest.

3 (g) In accordance with chapter 103D, the University may  
4 enter into written contracts with collection agencies for the  
5 purpose of collecting delinquent loans. All payments collected,  
6 exclusive of a collection agency's commissions, shall revert,  
7 and be credited, to the Hawaii educator loan program special  
8 fund. A collection agency that enters into a written contract  
9 with the University for the collection of delinquent loans  
10 pursuant to this section may collect a commission from the  
11 debtor in accordance with the terms of, and up to the amounts  
12 authorized in, the written contract."

13 SECTION 3. Section 304A-702, Hawaii Revised Statutes, is  
14 repealed.

15 [~~§304A-702~~] ~~Repayment of loans; waiver; collection.~~ (a)  
16 ~~All loans made under this subpart shall bear interest at five~~  
17 ~~per cent simple interest. Repayment of principal and interest~~  
18 ~~charges shall commence one year after graduation or three months~~  
19 ~~after a loan recipient ceases to be enrolled in a state-approved~~  
20 ~~teacher education program and shall be paid in periodic~~  
21 ~~installments within a six-year period. The university may~~

7 ~~shall be waived for every year of the first five years, and the~~

1 SECTION 4. There is appropriated out of the general  
2 revenues of the State of Hawaii the sum of \$250,000 for fiscal  
3 year 2007-2008 to be deposited into the Hawaii educator loan  
4 program special fund to be used for student loans.

5 SECTION 5. There is appropriated out of the Hawaii  
6 educator loan program special fund the sum of \$250,000 or so  
7 much thereof as may be necessary for fiscal year 2007-2008 to be  
8 used for student loans.

9 The sum appropriated shall be expended by the University of  
10 Hawaii for the purposes of this Act.

11 SECTION 6. Statutory material to be repealed is bracketed  
12 and stricken. New statutory material is underscored.

13 SECTION 7. This Act shall take effect on July 1, 2007.
