A BILL FOR AN ACT

RELATING TO HIGHWAY SAFETY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 286-209, Hawaii Revised Statutes, is
2 amended by amending subsection (a) to read as follows:

3 "(a) Motor carrier vehicles, including but not limited to
4 trucks, truck-tractors, semitrailers, trailers, or pole trailers
5 having a gross vehicle weight rating of more than [~~10,000~~] ten

8 which transport passengers in the furtherance of a commercial
9 enterprise, including car rental transport vehicles shall be
10 inspected and certified [~~once every twelve months during the~~
11 ~~month in which the vehicle's certificate of motor vehicle~~
12 ~~registration is issued.~~] annually."

13 SECTION 2. Statutory material to be repealed is bracketed

15 SECTION 3. This Act shall take effect on January 1, 2008.
