Department Mission:

The mission of the State of Hawaii, Department of Defense, which includes the Hawaii National Guard (HING) and Hawaii Emergency Management Agency (HI-EMA), is to assist authorities in providing for the safety, welfare, and defense of the people of Hawaii. The department maintains its readiness to respond to the needs of the people in the event of disasters, either natural or human-caused.

Some Statewide Conditions:

Our HIDOD budget has at least one notable shortfall: there are not enough funds to cover our current state employee payroll for the entire FY, leaving the department to make up the shortfall with position vacancies and funding from operations. Additionally, there are no provisions to fund State Active Duty for our soldiers and airmen in the event of large-scale civil emergencies.

Federal Funds

C. The DEF 110 Federal funds budget is \$91.5 million with a \$104.5 million total operating budget. The federal funds are distributed through the National Guard Bureau based upon the Master Corporate Agreement for the various contracted programs. The federal funds associated with the U.S. Department of Defense is not in jeopardy of being lost. The current Federal Budget has funded the National Guard Bureau with sufficient funding for a full federal fiscal year (ends September 30, 2017) operation.

Budget Requests

D. The budget process for the supplemental budget year allowed each division to review their operation and submit requests which have been identified as operational issues or needs to their budgets which were unplanned. Each Form A and CIP submission was reviewed for alignment to the Adjutant General and the Governor's

initiatives along with the operational justification of the request. The priority of the requests is based upon the alignment with the needs of the department and since all of the requests have been vetting and following fiscal prudent reasoning, assigning priorities is extremely difficult.

 - 12) State matching for Veteran Services operation (\$828,400 25/75)
 - 13) Reduction of non-reoccurring funds for motor vehicles. (-\$55,000)
