On behalf of Hawaii Children's Action Network (HCAN), we are writing to support the intent of SB 522 – Relating to Human Services

HCAN believes that providing a safe environment for children to sleep in while in a childcare setting is vital. HCAN has been working with the Department of Human Services (DHS) to update their administrative rules to address this issue. These new rules were just adopted on Friday.

SB 522 addresses the Safe Sleep policies for children under age one, yet does not address children over age one. This bill should be expanded to better match the administrative rules adopted last week by DHS.

In addition to the administrative rules and this bill, there should be a companion community education program to help educate families in addition to the child care workers on safe sleep practices for children.

For these reasons, HCAN respectfully requests that the committee add the safe sleep requirements for children over age one to be consistent with the Department of Human Services.

HCAN is committed to building a unified voice advocating for Hawaii's children by improving their safety, health, and education. Last fall, HCAN convened input in person and online from more than 50 organizations and individuals that came forward to support or express interest for a number of issues affecting children and families in our state that resulted in the compilation of 2017 Hawaii Children's Policy Agenda, which can be accessed at http://www.hawaii-can.org/2017policyagenda.
