TESTIMONY TO THE HOUSE COMMITTEE ON HIGHER EDUCATION AND TECHNOLOGY

Senate Bill 135, SD2 – Relating to Telecommunication

The Disability and Communication Access Board (DCAB) supports Senate Bill 135, SD2, which requires the Office of Enterprise Technology Services to establish a working group and conduct a study to determine appropriate state office buildings that can provide equitable telecommunication access to allow residents and residents with disabilities from the Counties of Hawaii, Kauai, and Maui and rural areas of the City and County of Honolulu to remotely participate in legislative hearings.

Title II of the Americans with Disabilities Act (ADA) requires state and local governments to provide equal access for individuals who are disabled when providing services, programs, or activities. When it comes to determining appropriate state office buildings where residents can remotely participate in legislative hearings, it is important to ensure that the identified buildings and programs are equally accessible to the full spectrum of persons with disabilities, especially those with communication disabilities.

SD2 of this measure includes the requirement to establish a working group. To the extent where the working group considers disability access, persons with communication disabilities should be represented on the working group to ensure minimum ADA requirements are met. Communication disabilities include deafness, hearing loss, blindness, and vision impairment. All aspects of remote participation in legislative hearings must be equally accessible, including the ability to provide testimony and follow legislative proceedings, which are required, in addition to making hearing notices and other legislative documents accessible.
