TESTIMONY ON SENATE BILL 2637 RELATING TO PUBLIC SAFETY. by Max N. Otani, Director Department of Public Safety

Chair Nishihara, Vice Chair DeCoite, and Members of the Committee:

Senate Bill (SB) 2637 seeks to mandate that there be a community-based work furlough program for all incarcerated women in the State and appropriates an unspecified amount of funding for this purpose. The Department of Public Safety (PSD) offers the following comments regarding this well-intentioned measure.

PSD wishes to clarify that work furlough programs are available to sentenced felons, not sentenced petty misdemeanants, as the terms of incarceration of the latter range from 30 days up to 1 year of incarceration, too short a period in which to conduct a meaningful work furlough program and therefore, inappropriate for the short-term transient female population.

At present, PSD provides work furlough programs at all jail facilities statewide (HCCC, KCCC, OCCC, MCCC, and WCCC). Although these programs have been temporarily suspended due to the COVID-19 pandemic, the Department will reopen the programs as soon as the coronavirus has been demonstrably reduced over a sustained period and it is safe to do so. of the extended duration of the pandemic, PSD has sought to expand extended furlough programs at these facilities for both male and female inmates, which has shown to benefit these offenders. This expansion will continue even after the work furlough programs are reopened.

In addition, the Department presently contracts with the YWCA of Oahu to provide a work furlough at Fernhurst, primarily serving WCCC, and the Women in Need contracted program, serves extended furloughees plus an additional program that offers related services to women offenders.

The Department also notes that any expansion in current programs and/or new initiatives will require additional funding. The highly beneficial work furlough and extended furlough programs require considerable resources, especially when PSD will be tailoring work furlough to more specifically address the needs of female offenders.

SB 2637 - SUPPORT STATEWIDE WORK FURLOUGH PROGRAMS FOR WOMEN

Aloha Chair Nishihara, Vice Chair DeCoite and Members of the Committee!

My name is Kat Brady and I am the Coordinator of Community Alliance on Prisons, a community initiative promoting smart justice policies in Hawai`i for more than two decades. This testimony is respectfully offered on behalf of the more than 4,103 Hawai`i individuals living behind bars or under the "care and custody" of the Department of Public Safety or the corporate vendor on any given day. We are always mindful that 1,113 of Hawai`i's imprisoned people are serving their sentences abroad thousands of miles away from their loved ones, their homes and, for the disproportionate number of incarcerated Kanaka Maoli, far, far from their ancestral lands.

Community Alliance on Prisons is in strong support of this measure for statewide work furlough programs for women. The system is normed to medium security, violent males, so their numbers (3,679) are far greater and males get more attention than incarcerated women (424). The department's January 17, 2022 population report showed that women represented about 8% of the total incarcerated population (4,103).

We know that many of the women are mothers, therefore, helping them develop work skills to facilitate their reentry is a win-win situation for themselves, their families, and the community!

We urge the committee to pass this measure onto WAM with a recommendation for appropriate funding.

Chair Nishihara, Vice Chair DeCoite and Members of the Committee:

The Hawaii Corrections System Oversight Commission was created by Act 179, SLH 2019, to provide independent oversight over our correctional system. The Commission's statutory responsibilities include monitoring and reviewing the comprehensive offender reentry program of the Department of Public Safety and ensuring that the comprehensive offender reentry system under chapter 353H is working properly to provide programs and services that result in the timely release of inmates on parole. [See Hawaii Revised Statutes 353L-3(b).]

The Commission strongly supports SB 2637, which would require community-based work furlough programs for incarcerated women in Hawaii. This mandate would be consistent with the requirement in HRS 353H-3 that the Department of Public Safety develop a "comprehensive network of transitional programs to address the needs of individuals exiting the correctional system." Such a network promotes community safety by facilitating the adjustment from the highly structured prison setting to independent living. These transitional services work best when located in the communities into which the inmates will return. In these settings programs can provide navigational supports as the inmate adjusts to the demands of life in the community; and much needed emotional support.

Very frequently, such services are best provided by non-profit agencies whose focus is on assisting inmates within their communities. Hawaii has a rich history of such services. They include the Fernhurst YWCA in Honolulu; the Maui Best program on Maui, and the Going Home Consortium on Hawaii Island. These agencies have been a critical part of the correctional system "infrastructure" for years. For example, the Fernhurst program and its predecessors have provided services since the 1970s. They have struggled, and often they are underutilized. But they remain resilient because they are dedicated to their mission and many in the communities recognize their value.

SB 2637 will be an important step toward ensuring that this network of communitybased services can not only survive, but perhaps thrive. They will play a central role as Hawaii moves to a rehabilitative and therapeutic model of corrections. We urge you to pass this bill.

RELATING TO PUBLIC SAFETY

The Department of Budget and Finance (B&F) offers comments on Senate Bill (S.B.) No. 2637.

S.B. No. 2637 amends Section 353-6.5, HRS, by mandating a community-based work furlough program for all incarcerated women in the State; and appropriates an unspecified amount of general funds to the Department of Public Safety for FY 23 to ensure the continuation of community-based work furlough for women and its expansion to all incarcerated women. This bill intends to ease family reunification efforts and provide for gender-responsive, community-based programs for the eventual integration of incarcerated women back into the communities.

B&F notes that the federal Coronavirus Response and Relief Supplemental Appropriations Act requires that states receiving Elementary and Secondary School Emergency Relief (ESSER) II funds and Governor's Emergency Education Relief II funds must maintain state support for:

EMPLOYEES' RETIREMENT SYSTEM HAWAI'I EMPLOYER-UNION HEALTH BENEFITS TRUST FUND OFFICE OF THE PUBLIC DEFENDER

- Elementary and secondary education in FY 22 at least at the proportional level of the state's support for elementary and secondary education relative to the state's overall spending, averaged over FYs 17, 18 and 19; and
- Higher education in FY 22 at least at the proportional level of the state's support for higher education relative to the state's overall spending, averaged over FYs 17, 18 and 19.

Further, the federal American Rescue Plan (ARP) Act requires that states receiving ARP ESSER funds must maintain state support for:

- Elementary and secondary education in FY 22 and FY 23 at least at the proportional level of the state's support for elementary and secondary education relative to the state's overall spending, averaged over FYs 17, 18 and 19; and
- Higher education in FY 22 and FY 23 at least at the proportional level of the state's support for higher education relative to the state's overall spending, averaged over FYs 17, 18 and 19.

The U.S. Department of Education has issued rules governing how these maintenance of effort (MOE) requirements are to be administered. B&F will be working with the money committees of the Legislature to ensure that the State of Hawai'i complies with these ESSER MOE requirements.
