Chairs Nishihara and San Buenaventura, Vice Chairs DeCoite and Ihara, and Members of the Committee:

The Hawaii Corrections System Oversight Commission was created by Act 179, SLH 2019, to provide independent oversight over our correctional system. The Commission's statutory responsibilities include monitoring and reviewing the comprehensive offender reentry program of the Department of Public Safety and ensuring that the comprehensive offender reentry system under chapter 353H is working properly to provide programs and services that result in the timely release of inmates on parole. [See Hawaii Revised Statutes 353L-3(b).]

The Commission strongly supports SB 3294, which would funding for reentry planning circles for incarcerated women in Hawaii. This mandate would be consistent with the requirement in HRS 353H-3 that the Department of Public Safety develop a "comprehensive network of transitional programs to address the needs of individuals exiting the correctional system." Such a network promotes community safety by facilitating the adjustment from the highly structured prison setting to independent living. These transitional services work best when the link inmates in prison with the communities to which they inmates.

Reentry planning circles effectively help inmates re-connect with their families and other loved ones. Family connection is a crucial element in successful reentry. Our only

concern with this bill is that it is limited only to women inmates. It is a good start, nevertheless, and we urge your favorable consideration.

The Department of Public Safety (PSD) has reviewed Senate Bill (SB) 3294, which seeks to appropriate \$200,000.00 to fund reentry circles for a minimum of fifty (50) incarcerated women and offers the following comments.

PSD believes the therapeutic processes that may result from participation in reentry circles would best serve offenders and their families as part of jail diversion programs, not after conviction and sentencing. The potential positive outcomes of these types of circles could possibly serve as very effective intervention strategies in community-based incarceration diversion initiatives.

RELATING TO REENTRY PLANNING CIRCLES

The Department of Budget and Finance (B&F) offers comments on this bill.

Senate Bill No. 3294 appropriates \$200,000 in general funds to the Department of Public Safety for FY 23 to fund reentry planning circles for at least 50 incarcerated women. This bill is intended to lower recidivism rates and provide solution-based planning processes for the development of detailed plans for obtaining housing, employment, and other necessities upon the release of inmates from incarceration.

B&F notes that, with respect to the general fund appropriation in this bill, the federal Coronavirus Response and Relief Supplemental Appropriations Act requires that states receiving Elementary and Secondary School Emergency Relief (ESSER) II funds and Governor's Emergency Education Relief II funds must maintain state support for:

 Elementary and secondary education in FY 22 at least at the proportional level of the state's support for elementary and secondary education relative to the state's overall spending, averaged over FYs 17, 18 and 19; and Higher education in FY 22 at least at the proportional level of the state's support for higher education relative to the state's overall spending, averaged over FYs 17, 18 and 19.

Further, the federal American Rescue Plan (ARP) Act requires that states receiving ARP ESSER funds must maintain state support for:

- Elementary and secondary education in FY 22 and FY 23 at least at the proportional level of the state's support for elementary and secondary education relative to the state's overall spending, averaged over FYs 17, 18 and 19; and
- Higher education in FY 22 and FY 23 at least at the proportional level of the state's support for higher education relative to the state's overall spending, averaged over FYs 17, 18 and 19.

The U.S. Department of Education has issued rules governing how these maintenance of effort (MOE) requirements are to be administered. B&F will be working with the money committees of the Legislature to ensure that the State of Hawai'i complies with these ESSER MOE requirements.

SUPPORT FOR SB3294 RELATING TO REENTRY PLANNING CIRCLES

The Women's Prison Project (WPP) **STRONGLY SUPPORTS** SB3294 to appropriate \$200,000 to provide the reentry planning process, known as huikahi circles, for at least 50 women incarcerated at WCCC.

Reentry planning by individual incarcerated people is vital for their successful return to the community and their desisting from crime (Taxman, 2004).

Huikahi circles are for incarcerated people who take responsibility for their behavior and want to make amends with harmed loved ones and the community—and who want to plan for their transition back into the community. They have been provided at several state prisons, but mainly at WCCC.

The huikahi circles have been provided pro bono and with private grants to the state prisons. Except for the state's federal 2021 GEER grant, the state has never funded the process for adults.

The process has been extensively researched. It is healing for children of incarcerated parents and other loved ones. An independent evaluation of the process shows it reduces recidivism. Another study shows it can help decrease Hawaii's prison population.

We urge the joint committees on Human Services and Public Safety, Intergovernmental and Military Affairs to please pass SB3294.

SB 3294 - STRONG SUPPORT FOR REENTRY PLANNING CIRCLES

Aloha Chairs Nishihara and San Buenaventura, Vice Chairs DeCoite and Ihara, and Members of the Committees!

My name is Kat Brady and I am the Coordinator of Community Alliance on Prisons, a community initiative promoting smart justice policies in Hawai`i for more than two decades. This testimony is respectfully offered on behalf of the more than 4,085 Hawai`i individuals living behind bars or under the "care and custody" of the Department of Public Safety or the corporate vendor on any given day. We are always mindful that 1,111 of Hawai`i's imprisoned people are serving their sentences abroad thousands of miles away from their loved ones, their homes and, for the disproportionate number of incarcerated Kanaka Maoli, far, far from their ancestral lands.

Community Alliance on Prisons is in strong support of this measure for statewide work furlough programs for women. The system is normed to medium security, violent males, so their numbers (3,691) are far greater and males get more attention than incarcerated women (394). The department's January 24, 2022 population report showed that women represented almost 10% of the total incarcerated population (4,085).

We know that many of the women are mothers, therefore, helping them develop work skills to facilitate their reentry is a win-win situation for themselves, their families, and the community! Women cannot support their families without proper training for jobs that will pay them a wage that will enable them to take care of themselves and their families.

We urge the committee to support women. Mahalo for this opportunity to testify.

Mahalo for hearing SB3294 relating to reentry planning circles. I am writing in **strong support** of SB3294 because I believe in the importance of reentry planning circles.

Reentry planning circles are paramount to one's success upon reentry for three reasons:

- 1. Formerly incarcerated people experience isolation upon reentry due to strained familial bonds and community support.
- 2. It is difficult to adjust to the changes in this age of rapid advancement.
- 3. People lose their autonomy upon incarceration; therefore, it becomes difficult to speak for themselves and manage their time.

A plan and support system that is implemented BEFORE reentry will help alleviate uncertainty and help the individual stay on track. Incarceration alone will not rehabilitate someone, they need structure, education, guidance, and support. SB3294's plan to provide support for at least 50 women will have a positive impact on at least 50 families. I am reaffirming my **strong support** for SB3294.

I am providing written testimony on behalf of the Women's Prison Project in support of S.B. 3294. I support this bill because I believe that it is vital for our incarcerated women to receive the tools they need to successfully transition back into the community. While incarcerated at WCCC, our women receive traumainformed care. This type of care establishes safe and nurturing conditions so that our women can begin the rehabilitation and healing process; they identify and address the core issues of their beliefs and behaviors; and gain sense of forgiveness and change for themselves, their 'ohana, and the community. I view reentry planning circles as a final piece to the puzzle which is reintegration. These circles help our women prepare for life outside of prison and helps to address key factors for survival and success in the community. Through these circles, our women receive assistance developing detailed plans to obtain housing, employment and other necessities vital to survival, as well as building on and maintaining the sense of forgiveness by helping our women establish and/or repair relationships with 'ohana and others. But, as crucial as huikahi restorative circles are, availability and resources are limited so funds are in dire need. I humbly ask the Committees for their consideration in support of S.B. 3294.
