In consideration of HOUSE BILL 535 RELATING TO HUNTING

House Bill 535 requires the Department of Land and Natural Resources (Department) to create and periodically update a game management plan. Requires the Board of Land and Natural Resources to establish a certified public hunter program to address the growing problem of wild pig populations in residential areas. **The Department opposes the measure** since our hunting program already works well without it.

The Department's existing game management program established under Hawaii Revised Statutes 183D establishes a comprehensive program for game management and hunter opportunities, consistent with the intent of the proposed legislation. The Department also supports a "certified public hunter program," which includes feral pigs, through its hunting license program.

The Department believes the proposed legislation would be duplicative of our existing program.

Chair Ichiyama, Vice Chair Poepoe, and Members of the Committee,

The Hawaii Cattlemen's Council (HCC) is the Statewide umbrella organization comprised of the four county-level Cattlemen's Associations. Our member ranchers represent over 60,000 head of beef cows; more than 75% of all the beef cows in the State. Ranchers are the stewards of over 750 thousand acres of land in Hawaii, or 20% of the State's total land mass. We represent the interests of Hawaii's cattle producers.

The Hawaii Cattlemen's Council **<u>supports HB535</u>** which requires the Department of Land and Natural Resources to create and periodically update a game management plan and requires the Board of Land and Natural Resources to establish a certified public hunter program to address the growing problem of wild pig populations in residential areas.

Hawaii's ranchers have been addressing the invasive ungulate issue with the resources they have access to. This includes trapping, harvesting, managing access for hunting, installing fences, and working with neighboring ranches to coordinate these efforts. Aloha Chair Ichiyama, Vice-Chair Poepoe, and Members of the Committee:

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate and advance the social, economic, and educational interests of our diverse agricultural community.

The Hawai'i Farm Bureau offers the following support with comments relating to HB 535, which would require the DLNR to create and update a game management plan and establish, among other things, a certified public hunter program to address the long-standing problems caused by the uncontrolled wild pig population throughout the State, even in residential areas.

HFB supports many of the concepts promoted in this bill. Game management is a crucial responsibility of the State and not an easy task. A comprehensive management plan with periodic updates is the first step in the process of taking control of the current situation. Feral animal management, especially wild pig management, must be addressed to protect agricultural crops, conservation areas, and natural resources such as our watersheds and important plant and animal species, and for many other reasons.

We agree that feral pigs can provide much-needed food for our local communities and that a well-thought-out program of certifying hunters, increasing access to slaughter units and meat inspection sites for wild-caught meat, and helping with the marketing of this product could go far to achieve that goal.

HFB would like to offer the following concerns:

(1) That hunting on private lands by certified public hunters, or others, should not be mandatory or conducted without the written consent of the private landowner; and

(2) That the hunting program *must* include adequate training, vetting, and enforcement to ensure the safety of residents, their property and livestock, and the hunters themselves. HFB is concerned about the difficulty in enforcing a hunting program that could result in people or non-target animals inadvertently being killed.

As a Pupukea landowner with deep personal experience of the feral hog invasion on O'ahu, I was shocked to learn about this utterly superfluous proposed allocation of taxpayer dollars.

The establishment of a "certified public hunter program" is a wasteful re-inventing of the wheel because not only is there already a group of fully-certified and licensed hog hunters, all card-carrying members of The O'ahu Pig Hunters Association who are very very good at controlling the feral hog population-- they provide this service at absolutely no cost.

My shock in regards to this bill is twofold: 1) the Hawaii DLNR knows all about its president Roy Kainoa and his members: anyone who calls the DLNR number is immediately referred to Roy. I know this because this is how I found him myself.

Secondly, I have personally had several lengthy conversations about the feral hog problem with the Hawaii director of this USDA task force, a woman named Susan whose last name I cannot recall-- and with the biologist in charge, Homer Leong, to whom Susan referred me. Neither was aware of the OPHA; both were delighted to learn that such a group existed and assured me that they would happily refer any members of the public who contacted them to Roy and his group.

Knowing that both the head of the task force and the lead biologist now know about this wonderful and very efficacious free public service, I am utterly mystified as to why there would be any perceived need on the part of the USDA/DLNR to establish a new group that would only duplicate a pre-existing solution.

Let me assure you that it would be impossible to find a more dedicated, effective and persistent group than the OPHA. I went from being totally overrun with bands of marauding feral pigs that came close to destroying my 1-acre fruit farm to not having seen a single pig for the last 6 months-- after only 4 visits from the bow-and-arrow hunters of OPHA. They were full of aloha, very justifiably proud of their hunting prowess, completely silent and respectful, and very *pono*.

Their intended targets die instantly without a sound, as I have personally witnessed. They do not shoot until the pigs are completely relaxed and they kill with a single arrow, so there is no trauma-- for the pig or the homeowner. And they eat every single pig they kill, or donate to those who are food insecure in our community. They are Hawaiian men, 3rd and even 4th generation hunters for whom pig hunting is a cultural practice.

They arrive in a timely manner, and they keep on coming until the property owner reports that there are no more pigs. Even 6 months later, they call me periodically to make sure that the pigs have not returned. All of their services are 100% free. I am very sure that this service, at least in its currently existing form, would be impossible to duplicate.

But again, my point in submitting this testimony is that there is NO NEED to re-invent the wheel, nor to waste our taxpayer dollars trying to do so. Let us support wholeheartedly this uniquely Hawaiian highly functional and *pono* resource that we have in the OPHA. This Bill HB535 should NOT be passed. Mahalo,
