SB 420 - RELATING TO SUSTAINABLE FOOD SYSTEMS

Chair Gabbard, Vice Chair Richards, and Members of the Senate Committee on Agriculture and Environment:

Thank you for the opportunity to provide testimony in support of SB 420 relating to sustainable food systems which establishes the sustainable food systems working group within the Hawai'i Department of Agriculture. The purpose of this working group is to develop an interagency food systems plan linked to the United Nations Sustainable Development Goals for a more sustainable, resilient local food economy that enhances and sustains the environmental, economic, and social health of the community.

A sustainable food system is defined as one that provides sufficient food to meet current food needs while maintaining healthy ecosystems that support continuous food production for generations to come. To ensure equitable access to nutritional food that is produced with minimal impact on the environment, Hawai'i needs to encourage the development of sustainable food systems. Our food systems need to be serving our population's health, the environmental health of our land, and the economic health of our food and agricultural sector. Hawai'i needs to be proactive in making locally produced food widely available to our population. Similar to other parts of the world, Hawai'i is especially vulnerable to natural and human disasters that may have a negative impact on our own food security. Hence, the establishment of a working group focused on making our local food production more sustainable is one we certainly support.

Thank you for the opportunity to submit testimony in support of this bill provided that its passage is in addition to and does not replace or adversely impact priorities as indicated in our BOR Approved Budget.

#### In support of Senate Bill 420 RELATING TO SUSTAINABLE FOOD SYSTEMS

Senate Bill 420 establishes the sustainable food systems working group within the department of agriculture (DOA). Requires the working group to submit a plan, any recommendations for implementing the plan, and any proposed legislation to the legislature. Appropriates funds to establish the working group and develop the plan and for an unspecified number of sustainability specialist positions to be employed by DOA. The Hawai'i Climate Change Mitigation and Adaptation Commission (Commission) offers the following comments in <u>support</u> of this measure.

The Commission's working paper *Nature-Based Resilience and Adaptation to Climate Change in Hawai'i* recognizes that Climate impacts to agriculture, fisheries, and food system infrastructure have steadily increased over the last 10 years and are projected to increase in severity over this century. Hawai'i, must prepare for more frequent and severe climate-induced shocks, disruption of critical supply chains and fisheries, increased food insecurity, and the catastrophic loss of life, livelihoods, property and infrastructure.

Simultaneously, the post-plantation agricultural economy of Hawai'i remains largely oriented toward external markets, with a diversified agriculture sector and regional food economy limited by a range of social, economic and political obstacles. Sustainably-managed agricultural systems can play a critical role in enhancing local food supplies, increasing resilience and adaptive capacity to climate change, and protecting Hawai'i's coral reefs ecosystems.

There are a number of models of sustainable food systems in Hawai'i, including approaches that incorporate indigenous management strategies, that can help to build resilience, and support biodiversity and ecosystem services. Recent research suggests that indigenous agroecosystems (including agroforestry, lo'i systems, and dryland agriculture) supported large populations of Native Hawaiians pre-European contact, and that many of the areas that these systems likely occupied are still viable today. By contrast, Hawai'i's legacy of plantation agriculture has left many of the most highly productive soils in the state in a degraded condition. There are, however, many producers interested in reversing this trend. Climate-smart agricultural management choices support soil health over time which provides beneficial outcomes for air and water quality, human health, groundwater recharge, nearshore ecosystem resilience, increased drought tolerance of crops and plants, reduced impacts of flooding, increased crop and livestock productivity, and overall ecosystem resilience.

With 41% of Hawai'i's agricultural lands currently unfarmed, there is a huge opportunity to lower the state's food importation rates while mitigating climate change and protecting native ecosystems and cultural/traditional practices. Locally-produced agriculture is a vital part of our economy. Combining cultural wisdom with new scientific methods, sustainable food systems can reduce carbon emissions and improve crop yields through utilizing cover crops, reducing tillage, agroforestry and other carbon smart practices. Establishing the sustainable food systems working group is a good first step in achieving this.

#### SENATE BILL NO. 420 RELATING TO SUSTAINABLE FOOD SYSTEMS

Chairperson Gabbard and Members of the Committee:

Thank you for the opportunity to testify on Senate Bill 420. There is a companion measure, House Bill 308. SB420 requires the Department of Agriculture (Department) to establish a 23-member "Sustainable Food Systems Working Group" that is responsible for creating an "Interagency Food Systems Plan" linked to the United Nations Sustainable Development Goals for a more sustainable, resilient local food economy that enhances and sustains the environmental, economic, and social health of the community. The Plan is to focus on the following issues:

- (1) Food as a human right and healthy food for all;
- (2) Social equity and food justice;
- (3) Food system resilience;
- (4) Agriculture and food system sustainability;
- (5) Food at the center of a circular economy;
- (6) Sustainable education, workforce development, and fair labor; and
- (7) Good food governance.

The Department is to provide necessary staff support. There are two appropriations to the Department in support of the Working Group and its efforts, and the hiring of an unspecified number of sustainability specialist positions. The Plan is to be submitted to the 2025 Legislature. The Department offers a comment and a recommendation.

The Department has been directed by the legislative and executive branches to focus on increasing local food self-sufficiency. Perhaps the issues that are the focus of the proposed 23-member Sustainable Food Systems Working Group could be best approached first by a smaller group who can better define deliverables for this effort and make action item recommendations to the Sustainable Food Systems Working Group before incorporating it into a plan that will need to be funded and implemented. Additionally, while the measure proposes the creation of additional specialist positions to the Office of Planning and Sustainable Development, the Department currently lacks adequate staffing to host and support a working group of this size and importance at this time.

Further, SB84 is very similar to SB420, but the former assigns the responsibility of the Working Group to the Office of Planning and Sustainable Development.

We recommend adjusting the working group to double the current producer voices and consider limiting/removing other entities to promote efficiency.

Dear Chair Gabbard, Vice-Chair Richards, and members of the Committees:

On behalf of the North Shore Economic Vitality Partnership (North Shore EVP), I would like to extend our support for SB 420, which will establish the sustainable food systems working group within the department of agriculture.

North Shore EVP was formed as a regional economic development non-profit. We conducted a community-based analysis of the North Shore region of Oahu with the assistance of California-based Collaborative Economics using New Economy Time Series data that included Dun & Bradstreet establishment data and was sourced for job data and establishment counts.

The best know outcome of this project was identification of food safety certification as a major obstacle for local farmers wishing to enter institutional and commercial markets. This led to the implementation of USDA GroupGAP, the state's only food safety training and certification program. We were successful in this example because our community recognized that the economic impact of agriculture included not just production but the full food chain of production, processing, distribution, and a range of support industries. The NETS data revealed agriculture's inter-dependence on other related sectors.

We believe that the sustainable food systems working group's charge to develop an interagency food system plan is premature without the data and analysis of a comprehensive, state-wide, food chain analysis that would identify companies, organization, and institutions that currently participate in Hawaii's ag economy.

We welcome the formation of a sustainable food systems working group as a positive first step that may help coordinate state-wide efforts in building a successful and prosperous agricultural sector.

The further development of sustainable food systems in Hawai'i addresses those DMAP actions, advances the goals of the Aloha+ Challenge, the principles of the 'Āina Aloha Economic Futures Declaration (to which HTA has committed), and moves us closer to a model of regenerative tourism. It also offers more avenues to capture visitor spending – over \$19 billion in 2022 – and keep those dollars circulating in Hawai'i.

HTA stands ready to participate in the Sustainable Food Systems Working Group, and appreciates the intent of SB84 to advance sustainable food systems in Hawai'i. We also defer to the Department of Agriculture on the implementation of this measure. Mahalo.

The Obesity Prevention Task Force (OPTF), a program of Hawai'i Public Health Institute<sup>i</sup> (HIPHI), is in **strong support of SB 420**, which establishes the sustainable food systems working group within the Department of Agriculture.

# <u>The lack of a sustainable food system impacts the resiliency of our communities.</u>

Hawai'i Public Health Institute (HIPHI) appreciates the opportunity to provide SUPPORT for **HB 420**. This measure establishes a working group within the Department of Agriculture that will include a diverse group of members who bring a variety of understanding and perspectives to the work of identifying areas to address to strengthen the food system in our state.

Hawai'i is faced with an escalating crisis as a variety of factors such as climate change, workforce challenges, increasing cost of land and water, natural disasters, and a tenuous food supply system. Life expectancy continues to decline in the United States. COVID-19 is a factor, but chronic diseases, such as heart and chronic liver disease, continue to rise.<sup>ii</sup>

In the 2018 Hawai'i Behavioral Risk Factor Surveillance System (BRFSS), 14% of adults in the state reported they were diagnosed with prediabetes; 12% with diabetes; 3% had coronary heart disease; 3% had a stroke; 32% had high cholesterol; and 34% had high blood pressure.<sup>iii</sup> To address these chronic diseases, and improve overall public health, a strong, sustainable, locally-based healthy food system, from which people can benefit, is necessary.

I am testifying in strong support of S.B. 420, with one suggested amendment.

As a law student at the William S. Richardson School of Law and a young adult living in Hawai'i, I see this bill as a major step forward in building a resilient future. I had the opportunity to attend COP 27 as part of the University of Hawai'i Delegation this December. I learned about how communities worldwide are adapting to and mitigating the effects of climate change that many regions have already started experiencing to an extreme degree. **About 85-90% of Hawai'i's food is imported,** which makes it particularly vulnerable to impending climate disasters that may disrupt shipping and the food supply. This bill is urgently needed to ensure we prepare by investing in a resilient, local food system.

**I suggest amending** Section (2)(b) to add one undergraduate and one high-school youth representative who work with local food sustainability communities to the working group. Youth perspectives need to be incorporated into the decision-making process. Youth representatives will also highlight the importance of this working group to young Hawaiians and, hopefully, inspire their involvement in the legislative process.
