## In consideration of HOUSE BILL 1809 RELATING TO OCEAN RECREATION COMMERCIAL PERMITS

House Bill 1809 proposes to require that any newly established ocean recreation management area include the same or greater number of commercial use permits (CUPs) as the number of permits applicable to the area before the establishment of an ocean recreation management area. **The Department respectfully opposes this measure and recommends supporting the administration's bill package regarding ocean commercial use permits.** 

The purpose of designated Ocean Recreation Management Areas is to reduce user conflicts. One of the main factors contributing to user conflicts is the proliferation of commercial activities occurring in the State's nearshore waters originating from the adjacent shoreline. The Department believes that the number of authorized CUPs is better regulated by administrative rules because the rulemaking process in Section 91-3, Hawaii Revised Statutes, ensures a *Ka Pa'akai* analysis for any impacts on Native Hawaiian traditional and customary practices, as well as ensuring that the community as a whole provides comment, rather than select special interest groups.

The Department has prepared a comprehensive bill package to address environmental impacts, user conflicts, and user safety in our state's ocean waters and recommends that the Legislature support this package. These bills are House Bills 2474, 2475, 2476, and 2477.

As a small native Hawaiian business owner with a tour boat operation, these proposed regulations would give me the chance to try to rebuild after losing our home, shop, place of business and small boats in the Lahaina Fire.

As a small native Hawaiian owned commercial ocean business my recovery would be near impossible if I were to go to auction with big businesses with deep pockets to try to attain a permit to operate my small group tours. This is the issue I see over and over again. The persons submitting these bills are out of touch with who is actually operating commercial business, many are like me (local, small businesses) that are eco-conscious and sustainable. When changes are made to support smaller operations, we will know decisions are being made for the people that live and work in the community, not just for the state's profit.

I am asking that this bill is supported to ensure small businesses like me can at least continue to operate and hopefully recover after all the losses we have experienced.

As a native Hawaiian, I would be forced to leave my home and island because decisions are being made by a group that has no accountability to the people they are making the decisions for. There is no benefit to this bill for the community, especially native Hawaiian's like myself. Find a way for these positions to be elected and with a term instead of giving them more power. I understand the importance of effective ocean recreation management, and I appreciate efforts to strike a balance between conservation and commercial activities. However, the current language of the bill fails to consider the practical implications on businesses like mine, which are unfairly targeted and constantly blamed for various issues.

The ocean recreation industry is often unfairly singled out for environmental concerns, safety issues, or other challenges that are not solely within our control. While we are a small, eco-minded native owned business committed to responsible practices, this bill unfairly places the burden on our industry without considering the broader context and the shared responsibility of all stakeholders.

I urge the committee to reconsider the proposed restrictions and work towards a solution that accommodates the interests of both conservation and the local business community. Collaborative discussions with stakeholders could lead to a more balanced approach that achieves the intended goals without unfairly scapegoating our industry.

To whom it may concern,

As a permit holder, member of the Haleiwa Harbor ocean community, and a small business owner I am absolutely shook by bill HB2477. First of all, the proposed extreme increase in the rate of our harbor fees would very likely already put me out of business and the same goes for 99% of the other commercial permittees amongst the islands.

As an operator of a small 6 passenger tour charter, my margins are slim, and handling the recent 50% addition to our monthly fees was already a challenge.

I understand and support the implication of laws that provide increased protection to the Hawaiian sea life, the land and the native people, but this bill will most certainly do the opposite. I also understand that slight increases in fees are inevitable due to inflation, the economy, taxes, etc.

However, the way in which this bill is being handled seems quite frankly criminal. There has been no warning to this drastic possible change or end to our way of life. None of us were notified by the state, by DOBOR, or by the harbor master about our livelihood being at stake. On the other hand, we are emailed, texted, and emailed again in the same day being notified that we cannot use the water spickets to clean our boats, that an expected amenity on the other side of the island is out of order, or are bombarded with fine implied warning signs at the wash down that we cannot use too much water (pressure too low to flush 70k engines).

RE: Opposition Testimony for HB1809

I am writing to express my strong opposition to HB1809, which proposes significant restrictions on commercial ocean activities in state waters, particularly on weekends and holidays. As a Scuba Diving Professional, these proposed regulations would have a severe impact on our operations and potentially jeopardize our ability to remain viable.

I have been an Open Water Scuba Instructor for the past decade. I have had the pleasure of working in a number of countries including Honduras, Indonesia, Samoa, Thailand, and Malaysia. Several years ago I returned to the United States to work in Maui. I joined Dive Maui in Lahaina, Hawaii and have been working there for over two years. Together with the owners, we have worked to create a successful scuba training facility helping to train not only recreational divers but also dive professionals. Always as a part of these courses, we emphasize conservation and ocean protection. We aim to create ocean ambassadors who will spread the word to others on saving and protecting the ocean and the importance of Hawaii in that mission.

We have been fortunate to have steady customers year around, without a measurable high or low season. Even during the pandemic, scuba diving was bringing tourists to Maui. This tourism brings money, jobs, and helps to cement Hawaii's reputation as a worldwide premier tourist destination.

In addition, between December and April, Dive Maui operates daily whale watching trips. I work as a whale naturalist on these trips. This business not only brings in tourists to Maui. But also educates thousands of people each season on the importance of conserving and protecting our ocean. We speak at great length about whales, the ocean, and the role of humanity in protecting both. Therefore, limiting, restricting or ending Dive Maui's ability to educate and train the public will have a detrimental effect on tourism, conservation, and the public's perception of Hawaii's role in ecotourism.

I understand the importance of effective ocean recreation management, and I appreciate efforts to strike a balance between conservation and commercial activities. However, the current language of the bill fails to consider the practical implications on businesses like mine, which are unfairly targeted and constantly blamed for various issues.

The scuba industry is often unfairly singled out for environmental concerns, safety issues, or other challenges that are not solely within our control. While we are committed to responsible practices, this bill unfairly places the burden on our industry without considering the broader context and the shared responsibility of all stakeholders.

I urge the committee to reconsider the proposed restrictions and work towards a solution that accommodates the interests of both conservation and the local business community. Collaborative discussions with stakeholders could lead to a more balanced approach that achieves the intended goals without unfairly scapegoating our industry.

I would appreciate the opportunity to further discuss my concerns during any upcoming hearings or meetings regarding this bill. Thank you for considering my testimony, and I hope that we can find a mutually beneficial resolution.

Comments:

Strong **oppositiion** of this measure to automatically provision permits to (even existing) commercial operators and activities without conducting a proper carrying capacity to include Ka Pa'akai Analysis and consultation with nearby managed area manager/co-managers, and community.

I understand the huge negative impact to ocean recreational businesses. Conversations are needed for all to best understand the complexity and the dire need to better manage boat facilities and recreational spaces as they impact natural and cultural resources, and communities. A business (to include its economic value to the community) still must give priority to the cultural and natural resources first, and the people of place and community.

This is a very difficult measure for the committee to decide all, however the big step to conduct a reassessment and carrying capacity of our ocean areas must be done with Ka Pa'akai Analysis, and assessing the impact to natural and cultural resources of the immediate and neighboring communities. It has to start now, if not when?

I recommend the following amendment: modify/add the language pertaining pg1, lines 12 - 15 related to transfer of ownership of vessel from personal ownership to business. Any transfer of vessel from personl to business operations, which in turn should trigger a permit update, should be re-evaluated into the carrying capacity model/assessment that DOBOR exercises. A personal vessel is likely to be less impactful to cultural and natural resources, as well to the community than a business vessel/operations. A boat owner has the option to transfer, but not be able to also (thru that transaction) to change the conditions of the use permit. All DOBOR issued permits should trigger this re-assessment just like that of an SAP.

Oppose HB1809, and support HB2477 w/ recommendations with these same amendments.
