HOUSE BILL NO. 2130 RELATING TO SUSTAINABLE FOOD SYSTEMS

Chair Gates, Vice Chair Kahaloa and Members of the Committee:

Thank you for the opportunity to testify on House Bill 2130. This bill establishes an 11-member Sustainable Food Systems Working Group (Working Group) that is to develop an Interagency Food Systems Plan (Plan) that is linked to goals established by the United Nations. The Plan will address seven broad areas and once implemented, will result in a more sustainable, resilient local food economy that enhances and sustains the environmental, economic, and social health of the community.

The Working Group is administratively attached to the Department of Agriculture (HDOA). This measure establishes an unspecified number of sustainability specialist positions with HDOA and appropriates funds for the same. There is an additional appropriation to HDOA to support the establishment and operation of the Working Group and includes potential purchase of services for a fee. The Plan and its recommendations for the implementation of the Plan are to be submitted to the 2025 Legislature. The Department supports and offers comments for amendments to this measure.



The Working Group is to be co-chaired by the HDOA Chair and the Director of the Department of Business, Economic Development, and Tourism, and a single representative from each house of the State Legislature as selected by the Speaker of the House and the President of the Senate, respectively. The selection of a single person with knowledge from each of the seven broad areas are to be made by the two legislative representatives (Page 2, lines 15-20).

HDOA recommends including a requirement to have agricultural operators represented in the 11-member Working Group and requests legislative guidance in defining and describing how farmers, ranchers, aquaculturists, and producers will be at the heart of the Plan to achieve a more sustainable food system. The Department appreciates that the discussions will add content to the Hawaii Farm Bill currently in development.

- 1. Food as a human right and health food for all;
- 2. Social equity and food justice;
- 3. Food system resilience;
- 4. Agriculture and food system sustainability;
- 5. Food at the center of a circular economy;
- 6. Sustainable education, workforce development, and fair labor; and
- 7. Good food governance

The HDOA is cautiously optimistic that the effort of the Working Group will result in a measurable, science-based, and functional Plan that will promote the State's highest priorities of increasing the economic viability of existing agricultural operations and assist in the establishment of new ones in direct support of increasing local food self-sufficiency and exports.

The HDOA suggests that a requirement for the sustainability specialist positions in the HDOA to assist in the development of the Plan be well-versed in Hawaii agriculture at the farm and ranch level and be specialists in sustainability.

Me ke Aloha, Chair Gates, Vice-Chair Kahaloa, and members of the HouseCommittee on Agriculture and Food Systems:

SB2130 establishes a one-year working group on sustainable food systems to be administered by the Department of Agriculture, with single positions nominated by officers of the House and Senate and additional positions from organizations representing various facets of the agricultural community.

The Agriculture and Food Security Committee has worked with strategic partners across the community to arrive at the conclusion that food systems must be explored in order to derive a strategic plan to increase affordable fresh local produce food destined for local working family tables, alleviating our dependence on importing 85-90% of our food, increasing local food security and improving local nutrition.

We believe that Hawaii has too long emphasized export agriculture over local markets, in order to diversify the agricultural base and to produce revenues for the State, demonstrating agricultural productivity. Two casualties include degraded soils and nearshore waters, and affordable fresh local produce.

However, we are persuaded that, while export agriculture plays an important role in generating support for infrastructure, the hard truth is that it cannot compete sufficiently with other parts of the globe for market share, and that there is insufficient revenue from local markets to sustain enough food production for local tables. In our opinion, food security lies in a stronger public role in agricultural support, much as it does with education or bus service. In order for an efficient mix of these sectors to provide true food security, food systems must be explored, with facilities for local value-added product deelopment, subsidies for farmer foods safety certifications, water and power infrastructure, marketing and delivery, and other facets of the industry.

We welcome a working group to explore these possibilities and lend convincing persuasion.

We do so by bringing together youth (ages 14-26), educators, policymakers, and nonprofits to evaluate and discuss climate action priorities and provide tangible steps to empower youth. Our hope is for youth to forge relationships with policymakers so that they can continue to work together throughout the legislative process in Hawai'i and beyond.

On December 9th, 2023, the Climate Future Forum was held at the Hawaii State Capitol. The event included over 80 youth, adults, legislators and staff members, and about 30 people from the community. One of the goals of this event was for youth to develop their legislative priorities for the 2023 legislative session. One of their priorities is centered around improving food systems. Therefore, the Climate Future Forum strongly supports this bill as a part of a suite of bills (HB2137 and HB2138) because by creating a coordinated food systems plan we will be able to:

- increase local food security through a coordinated approach
- achieve the state's goals for local food production and support local farmers
- diversify Hawai'i's economy by supporting a robust local food economy
- contribute to the local agricultural industry (new markets, more stability, more jobs)
- reduce food miles and associated greenhouse gas emissions

Please pass this bill out of your committee.
