## H.B. 2580 RELATING TO TRANSPORTATION

### House Committee on Transportation and Judiciary & Hawaiian Affairs

The Department of Transportation (DOT) **supports** H.B. 2580 which prohibits the removal of a manufacturer or factory-installed speed limiting device from an electric bicycle. Prohibits the operation of an electric bicycle, in which the manufacturer- or factory-installed speed limiting device was removed from the electric bicycle, on a public highway.

Delimiting, e-bike tuning, or de-restriction is a known hack that removes the pedal assist speed restrictions. Removing the speed limiting device and replacing with an aftermarket delimiter could result in bike reaching between 30 and 37 miles per hour.<sup>i</sup> Modifying an e-bike to go faster than designed will put the operator at greater risk of injury, voiding their manufactures warranty, and compromising the integrity of a lithium-ion battery, which can increase fire risk.

DOT offers the following suggestion, which would complement this measure by adding Classes of electronic bicycles to HRS 291C-1 and 286 to further clarify the electronic bicycles, and thus would allow enforcement of speed, limitations on age, location, roadway class in which the different classes of e-bicycles are allowed to operate.

- **Class 1:** Bicycle equipped with a motor that provides assistance only when the rider is pedaling, and that ceases to provide assistance when the electric bicycles reaches 20 mph.
- **Class 2:** Bicycle equipped with a throttle-actuated motor, that ceases to provide assistance when the electric bicycle reaches 20 mph.
- **Class 3:** Bicycle equipped with a motor that provides assistance only when the rider is pedaling, and that ceases to provide assistance when the electric bicycle reaches 28 mph.

When two or three wheeled electronic vehicles no longer have pedals, and or exceed 28 miles per hour, they should be treated under similar requirements as either mopeds, motor scooters, or motorcycles.

Passing this measure and adding a class system for electronic bicycles would put our policies in line with other states in regulating electronic bikes and as it would lay the foundation to create clarity and consistency for distributors and consumers.
