1 Fiscal Implications: N/A.

2 Department Testimony: The Department of Health (DOH) offers technical amendments only
3 and takes no position on the merits of the bill.

4 Should the Legislature move forward with this measure, DOH respectfully recommends

5 amendments in Hawaii Revised Statutes (HRS) that are unrelated to substantive department

6 operations, including but not limited to chapter 321, Hawaii Revised Statutes, which HB966

7 currently proposes.

8 A new chapter adjacent to chapter 327, HRS, is more appropriate since amending chapter 321,

9 HRS, "Department of Health," may erroneously give the impression that DOH regulates the

10 Right To Try. This measure permits manufacturers to offer trials with certain protections from

11 liability and indemnities, which are completely unrelated to activities at DOH. Examples of

12 chapters adjacent to chapter 327 are:

- 327G Advanced health care directives;
- 327H Pain patient's bill of rights; and
- 327L Provider Orders for Life-Sustaining Treatment;
- 16 All which are health-related but not the responsibility of the Department of Health.

[Chapter 321, Hawaii Revised Statutes, is amended by 3 adding a new section to be appropriately designated and to read as 4 follows:] The Hawaii Revised Statutes is amended by adding a new 5 chapter to be appropriately designated and to read as follows: 6 "CHAPTER 7 RIGHT TO TRY 8 s -1 Access to investigational drugs and..."
