TESTIMONY OF THE

ON SENATE BILL NO. 2240, SD 2, HD 1

RELATING TO ELECTIONS

April 2, 2024

Chair Yamashita and members of the House Committee on Finance, thank you for the opportunity to testify in support of Senate Bill No. 2240, SD 2, HD 1. This bill requires the Office of Elections to file an application with Electronic Registration Information Center, Inc. (ERIC), by June 30, 2025, for the State to be admitted as a member of the organization; requires the Office of Elections to share with each county the information and services made available by ERIC pursuant to the State's membership agreement with the organization; requires the Office of Elections and each county office that administers elections to use information and services made available by ERIC to verify their respective voter registration rolls; and makes an appropriation.

Joining ERIC would provide another tool for election officials to maintain the accuracy and integrity of the voter registration rolls by allowing us to compare our voter registration file and driver license/identification card file with other member states. This will permit election officials to determine if a voter has moved out of state, as they register to vote or obtain a driver license in another jurisdiction. Additionally, ERIC membership requires all driver license/identification card holders who are eligible to register to vote, but are not currently registered, to be sent a mailer encouraging them to register.

We estimate that it will cost \$149,000 in FY 2024-25 to join ERIC based on the \$25,000 application fee, \$42,500 annual membership fee, and approximately \$81,500 to conduct the initial mailing to driver license and state identification card holders who are not registered to vote as required for membership in ERIC, along with mailings to address in-state movers and cross-

state movers. The recurring costs, which we would submit as part of our annual budget request starting with FY 2025-26, would be approximately \$45,000 for the annual membership fee, which is recalculated each year by ERIC.

Aloha chair and committee members,

I am happy to have the opportunity to appear and testify about this ERIC legislation. This bill was brought before the State Elections Commission in February for discussion and vote, when asked for Commission approval by our Chair and on behalf of Mr Nago.

Testimony and discussion led to a vote by the State Election Commision to NOT support this legislation. Many of the concerns were about data security, invasive voter data sharing without voter approval, and unknown costs. Already of 31 states that joined ERIC, over 14 have already either left or are leaving ERIC. It bothers me particularly that they have no office, will not share where their servers are located, and has requirements the State Elections office MUST meet, yet does not state any fine or repercussions if the State misses the opportunity.

What is the actual cost to Hawai'i Taxpayers? If our offices are already behind in updating our voter rolls, how will more data entry requirements help them to catch up? What are the safety measures in place to ensure data breach security? Much of what Eric provides is already available to the Office of Elections.

At our last meeting of the State Elections Commission, I was disheartened to learn that after deliberating and voting in February, our decision to reject ERIC and not support this legislation was not shared with you.

I hope this new information gives you a reason to reconsider funding and passing this unnecessary legislation.

Chair Yamashita, Vice Chair Kitagawa, and Committee Members,

INTRODUCTION: Electronic Registration Information Center (ERIC), Incorporated is a private, non-profit, non-partisan organization.

I STRONGLY OPPOSE SB2240_SD2_HD1 for the following reasons:

- <u>Privacy issues</u>: Violation of federal statutes such as the Help America Vote Act, National Voter Registration Act, and Driver's Privacy Protection Act. The first statute provides states the authority and obligation to create and maintain electronic voter registration files but includes no provision that authorizes any state to outsource these obligations to a third party like ERIC. The outsourcing of voter registration list maintenance to ERIC may also violate the National Voter Registration Act, which protects from disclosure the identities of individuals who decline to register to vote. Finally, the Driver's Privacy Protection Act specifically shields from disclosure of the kind of data provided to ERIC by member states to conduct list maintenance. Additionally, personal identifiers such as name, birth date, and last 4 of SSN are shared with this private third-party organization.
- <u>Taxpayer financial burden</u>. Per ERIC website, "states who choose to participate are required to pay a fee. Some states are paying \$175,000 or more in annual dues." The Hawaii State Elections Office could use that money to improve the integrity of their election process such as cleaning the voter rolls, conducting hand counted paper ballot audits, and improved chain of custody procedures.
- 3. <u>Does not prevent illegal voting</u>: Per ERIC's website, it is a tool available to help election officials maintain more accurate voter rolls and detect possible illegal voting. There are no public records showing ERIC detected illegal voting. Furthermore, there is currently no citizen verification check. According to the City Clerk, individuals registering to vote sign a self-attestation statement that they are eligible voters even though it is not verified by an official election employee. ERIC is used to manipulate and inflate voter rolls.

Over 9 states have removed themselves from participating in ERIC Programs due to concerns over privacy issues and mismanagement. Please do not pass SB2240_SD2_HD1. Please vote NO.

As an Independent, I find it completely unacceptable that highly partisan organizations (ZUCKERBUCKS recipients; seed money funding by George Soros) are associated with this proposal and will be allowed access to Hawai'i's voter data. I oppose SB2240 SD2 HD1.

The Electronic Registration Info Center (ERIC) is highly controversial and problematic, so much so that in recent years nine states have terminated their ERIC contracts.

The current ERIC state membership count is 24 states plus Washington DC.

The Missouri Secretary of State cited one of the reasons for leaving ERIC as, "ERIC's benefits to Missouri are limited as only three of the eight states that boarder [sic] Missouri are members".

The Office of Elections written testimony from the January 30, 2024 Senate Judiciary Committee hearing on SB2240 reads that joining ERIC

"would provide yet another tool for election officials to maintain the accuracy of the voter registration rolls by allowing us to compare our voter registration file and driver license/identification card file with other member states".

What is ERIC's Reach to Target Voter Roll Maintenance Based on Hawai'i In- and Out-Migration Population Data Analysis?

The <u>2022 State of Hawai'i Databook</u>, which is the most current population data available, shows the states to which Hawai'i residents are moving (out-migration) and the states where people are leaving to move to Hawai'i (in-migration).

Which are the top out-migration states and are they members of ERIC? **The top 3 out-migration states are Texas, California, and Florida, none of which are ERIC member states.** Total Hawai'i population out-migration to ERIC non-member states is 65%.

Joining ERIC will only data capture approximately 35% of in- and out-migration to and from Hawai'i, as the majority of population shifts are to and from states that do not contract with ERIC.

Additional concerns with ERIC:

Voter Registration Duplications:

In a voter registration comparative analysis of ERIC-member states to nonmember states, data analysis in 27 states revealed nearly 700,000 duplicate registrations.

Jeffrey Young, Certified Analytics Professional (CAP[®]) with a master's degree in business analytics, assessed the permanent address changes in the National Change of Address

database, (NCOA) against 27 states' voter registration databases over a four-month period prior to the 2022 General Election.

Using the NCOA database, Young flagged all the voters who filed permanent mailing address changes between September 2022 and December 2022, which uncovered a staggering number of duplications.

Specifically, 693,686 duplications were discovered among voter registrations across 27 states analyzed, which represents only approximately 28% of the total possible combinations of the states.

An in-depth comparison of ERIC member states and non-member states showed that the **ERIC member states had approximately 50% higher rate per capita of duplicate registrants**. In other words, states that pay to belong to the ERIC system, which promises to help state election officials maintain clean voter rolls by cross- checking duplicate registrations, have significantly more duplications than states that are not ERIC members (full study available upon request).

Privacy Concerns:

Hawai'i residents' data, including name, address, DOB, drivers license number, last 4 digits of SSN, phone and email address when available, will be shared across state lines. ERIC provides each member state a targeted list of people that are not registered to vote. The membership bylaws require the state to contact at least 95% of these people within 90 days, soliciting them to register.

Instead of spending taxpayer's money on contracting with ERIC, a better use of resources would be to have the county clerks run the NCOA data more frequently, i.e., every 4-6 months, and crosscheck the data against the voter rolls to identify movers, as opposed to utilizing NCOA only in election years. When someone files a NCOA form it is only active for 6 months.

The Honolulu City Clerk's office only uses NCOA data to cross check the voter rolls before bulk mailings before elections. This means that the majority of people who moved away from Hawai'i and filed a NCOA form would never have received the election mailer to verify their address, and the counties would not receive the NCOA bounce back indicating that the voter has moved.

ERIC's Focus on Voter Registration:

Despite ERIC's claim to be focused on voter roll maintenance, ERIC has shifted their priority focus to identifying and contacting unregistered voters.

State contracts with ERIC require the state to reach out to "eligible but unregistered" voters (EBUs) from lists compiled by ERIC.

ERIC recently provided a list of unregistered voters to the Colorado Secretary of State, who then mailed out voter registration applications to 30,000 people. The problem is that these applicants were sent to noncitizens.

In a <u>recent report from the Public Interest Legal Foundation</u> (PILF), ERIC identified 168,000 EBUs in Virginia to target for voter registration. This list consisted of people that Virginia officials had listed as deceased, relocated, or felons and thus deemed ineligible to register to vote.

Does the Office of Elections and the county clerks have a filtering system akin to Virginia's to prevent ineligible voters from registering once they are targeted by ERIC?

Hawai'i does not verify citizenship upon voter registration, it is merely a self-attestation.

Joining ERIC will Duplicate Current State Voter Registration Efforts

Hawai'i makes it very easy for people to register to vote.

There is an online voter registration portal. We have preregistration for teenagers, automatic voter registration through the DMV, and same day registration.

There was even a <u>full-time job listing</u> posted this year with the Office of Elections focused on voter registration.

Here is an excerpt from the job listing:

"The Election Specialist position is located in the Voter Registration Section, Voter Services Branch of the Office of Elections, an agency attached to the Department of Accounting and General Services. The position implements, coordinates and evaluates mass voter registration programs **to maximize and equalize voter registration and participation statewide**; controls in-house voter registration programs and processing of materials; assists with the production and procurement of voter registration materials; provides administrative support to the section; and performs other related duties as assigned"

Hawai'i Elections Commission Stance on ERIC:

On February 20, 2024, the Hawai'i Elections Commission passed a motion by majority vote to OPPOSE the state of Hawai'i joining ERIC.

Considering all the issues outlined above I strongly urge you to oppose this bill.
