## RELATING TO ELECTIONS

January 30, 2024

Chair Rhoads and members of the Senate Committee on Judiciary, thank you for the opportunity to testify in support of Senate Bill No. 2240. This bill requires the Office of Elections to file an application with Electronic Registration Information Center, Inc. (ERIC), by January 1, 2025, for the State to be admitted as a member of the organization; requires the Office of Elections to share with each county the information and services made available by ERIC pursuant to the State's membership agreement with the organization; requires the Office of Elections and each county office that administers elections to use information and services made available by ERIC to verify their respective voter registration rolls; and makes an appropriation.

Joining ERIC would provide yet another tool for election officials to maintain the accuracy of the voter registration rolls by allowing us to compare our voter registration file and driver license/identification card file with other member states. This will permit election officials to determine if voters have moved to other jurisdictions, as they register to vote or obtain a driver license in another jurisdiction. Additionally, ERIC membership requires all driver license/identification card holders who are eligible to register to vote, but are not currently registered, to be sent a mailer encouraging them to register.

For the appropriation, we estimate that it will cost \$25,000 to join ERIC and approximately \$100,000 to conduct the initial mailing to driver license and state identification card holders who are not registered to vote as required for membership in ERIC. Our total request for FY 2024-25 would be \$125,000.

We also estimate the annual membership fee would be \$23,000. This estimate is based on voter registration, and we would ask for this funding as an ongoing budget request starting with Fiscal Year 2025-26.

Finally, in an abundance of caution, given any administrative issues related to the submittal of the required application, we would propose that Section 2 of the bill be amended to provide that the application be submitted no later than June 30, 2025, as opposed to January 1, 2025, to address any administrative issues related to the submittal of the required application.

INTRODUCTION: Electronic Registration Information Center (ERIC), Incorporated is a private, non-profit, non-partisan organization.

I oppose HB2240 for the following reasons:

- <u>Privacy issues</u>: Violation of federal statutes such as the Help America Vote Act, National Voter Registration Act, and Driver's Privacy Protection Act. The first statute provides states the authority and obligation to create and maintain electronic voter registration files but includes no provision that authorizes any state to outsource these obligations to a third party like ERIC. The outsourcing of voter registration list maintenance to ERIC may also violate the National Voter Registration Act, which protects from disclosure the identities of individuals who decline to register to vote. Finally, the Driver's Privacy Protection Act specifically shields from disclosure the kind of data provided to ERIC by member states to conduct list maintenance. Additionally, personal identifiers such as name, birth date, and last 4 of SSN are shared with this private third party organization.
- 2. <u>Funding</u>: the burden to fund the program is on the taxpayers. Per ERIC website, it is funded and governed by states that choose to join.
- 3. <u>Does not prevent illegal voting</u>: Per ERIC's website, it is a tool available to help election officials maintain more accurate voter rolls and detect possible illegal voting. There are no public records showing ERIC detected illegal voting. Furthermore, there is currently no citizen verification check. According to the City Clerk, individuals registering to vote sign a self-attestation statement that they are eligible voters even though it is not verified by an official election employee.

Please do not pass SB2240. Please vote NO.

### **Testimony for SB2240**

I oppose SB2240

The Electronic Registration Info Center (ERIC) is very problematic, so much so that in recent years nine states have terminated their ERIC contracts. That should be a red flag for Hawai'i!

Here are some issues identified with ERIC.

## **Voter Registration Duplications:**

In a voter registration comparative analysis of ERIC-member states to nonmember states, data analysis in 27 states revealed nearly 700,000 duplicate registrations.

Jeffrey Young, Certified Analytics Professional (CAP®) with a master's degree in business analytics, assessed the permanent address changes in the National Change of Address database, (NCOA) against 27 states' voter registration databases over a four-month period prior to the 2022 General Election.

Using the NCOA database, Young flagged all the voters who filed permanent mailing

address changes between September 2022 and December 2022, which uncovered a staggering number of duplications.

Specifically, 693,686 duplications were discovered among voter registrations across 27 states analyzed, which represents only approximately 28% of the total possible combinations of the states.

An in-depth comparison of ERIC member states and non-member states showed that the **ERIC member states had approximately 50% higher rate per capita of duplicate registrants**. In other words, states that pay to belong to the ERIC system, which promises to help state election officials maintain clean voter rolls by cross- checking duplicate registrations, have more duplications than states that are not ERIC members. (Data analysis study available upon request).

### **Privacy Concerns:**

Hawai'i residents' data, including name, address, DOB, drivers license number, last 4 digits of SSN, phone and email address when available, will be shared across state lines.

ERIC provides each member state a targeted list of people that are not registered to vote. The membership bylaws require the state to contact at least 95% of these people within 90 days, soliciting them to register.

ERIC uses advanced technology including Artificial Intelligence from Senzing. This data matching AI compares information collected by member states with USPS address data and Social Security death records. No one knows how else this data collected from the states is being used. In an interview, J. Christian Adams, attorney for the Public Interest Legal Foundation stated, "That's part of the smoke screen. ERIC learns who gets registered from their program, so they're able to micro target with whoever is partnered with ERIC. We don't know who they are interfacing all this data with. It could be Catalist, the massive Democrat database organization. We just don't know. I've talked to some ERIC Board Members who are Secretary of States. They don't even know what ERIC is doing. They've asked questions and can't get answers..."

The Missouri Secretary of State cites the following concerns in his <u>ERIC contract termination</u> <u>letter:</u>

- ERIC refuses to require member states to participate in addressing multi-state voter fraud.
- ERIC focuses on adding names to voter rolls by requiring a solicitation to individuals who already had an opportunity to register to vote and made the conscious decision to not be registered.
- ERIC allows for a hyper-partisan individual to be an ex-officio non-voting member on its governance board.
- ERIC unnecessarily restricts how Missouri utilizes data reports.
- ERIC's benefits to Missouri are limited as only three of the eight states that boarder Missouri are members.

Hawai'i makes it very easy for people to register to vote and to vote. We have preregistration for teenagers, automatic voter registration through the DMV, same day registration, and universal mailing of ballots.

We do not have a voter registration problem.

ERIC is essentially a partisan voter registration drive disguised as voter roll clean up.

Hawai'i needs to steer clear of ERIC.

## Comments:

I, Allison Nickolai wish to submit the following written testimony in opposition of SB2240. It is NOT in the best interest of the Hawaii electorate to support the codification of the ERIC (Electronic Registration and Information Center). I am a resident of Ohio which terminated the ERIC agreement in March, 2023- but the data harvesting continued until June, 2023. I wish to share the following 4 items for careful consideration before passing this into law:

1) Per the ERIC bylaws contained in the agreement, the State agrees to share its databases with ERIC including but not limited to voter registration database and the Bureau of Motor Vehicles entity that qualifies under the AAMVA. It is NOT limited to just voter registration information, and as a result elector's PII unrelated to voter registration is now in the hands of an NGO- and OUT of the protections of the government agencies. This is against personal privacy laws and as a resident of Ohio, I never consented for my BMV information or voter registration data to be sold.

2) This out of state agency appears to be in direct violation of HAVA tile 3 sections governing electronic voter files. It clearly states that information sharing agreements can be made WITHIN the state and with the BMV and SSA. ERIC is a 501c3 NGO- and is NOT registered and operating WITHIN the confines of the State of Hawaii. It serves to PROMOTE registration of EBU (eligible but un registered) voters, as it is an ANNUAL requirement for the member state to solicit 95% of their identified EBU's to register to vote. There are consequences and \$\$ penalties (increased annual fees) if the state does not comply. In 2020, ERIC identified 700,000 EBU's and in 43 days managed to "find and register" 321k (46%) of them. Ohio fared worse: identifying 110k EBU's but registered a whopping 202k (183%) of them in 45 days.

3) Where are these EBU lists coming from? In 10/2022, the CO SoS received its EBU list from ERIC (102k), did their "due diligence", reducing the list to about 52k EBU's. They DID NOT catch that 31k of the EBU's were non-citizens AND sent them a postcard solicitation to register to vote. The deputy SoS Chris Beall was required to report this, and additional supporting details can be found in an article located here: https://www.cpr.org/2022/10/07/colorado-voter-registration-notices-non-citizens

4) Lastly, when you gauge the accuracy of ERIC states vs NON-ERIC states with respect to the accuracy of the voter rolls, the NON-ERIC states had fewer anomalies than the ERIC states. \*anomalies defined as inaccurate addresses, duplicate records, voters double registered in other states, deceased voters remaining on the rolls, etc.

Please do not allow any outside NGO interference in your voter rolls- ESPECIALLY ERIC. There is ZERO transparency or reports available by public records requests for the actual results of their voter registration maintenance. HAWAII- you have legitimate access to all the data bases you need to maintain your own voter rolls. NCOA for moves within the state and out of the state, health department records for death certificates, and BMV ID's and updates as well as the BMV being the LARGEST source of all voter registrations and photo ID's in accordance with NVRA and HAVA. (per EAC bi-annual Election Administrator Voting Survey released in late 2023 and covering 2020-2022 data). Learn from Ohio, CO, and Michigan. The resulting voter roll cleanup is NOT worth the price of your admission.

Thank you for allowing me to submit testimony opposing this bill.

The Office of Elections or State/County agency responsible for the task of updating voter registration rolls should already be doing this work. If the State agency responsible for this task has not done so, then funding for that agency should be reduced for this budget cycle by \$25,000 for every year voter registration rolls were not updated and every future budget cycle thereafter until voter registration rolls are updated.

If funding of this task is appropriated to the different counties, then that funding should be reduced proportionally by the number of voters in the county over the total number of voters in the State.

SB2240 should be tabled.

Aloha, my name is Jessica Malia Tamaribuchi and I am a resident of Kailua-Kona on the island of Hawaii. Today I am submitting written testimony firmly opposing SB2240 relating to elections. I oppose the State of Hawaii becoming a member of the Electronic Registration Information Center, Inc. (ERIC) for the following reasons:

1). ERIC requires that member states provide data on voters in order to maintain voter rolls. This could be a violation of the National Voter Registration Act and the Driver's Privacy Protection Act.

2). ERIC places a higher priority on voter registration above cleaning up voter rolls due to ineligibility. According to Judicial Watch "ERIC has been far more successful at identifying unregistered voters than duplicate or invalid registrations. The organization reports identifying more than 60 million unregistered voters since 2012." In fact, there's no requirement that member states "remove ineligible voters from their registration rolls." All member states are only required to "initiate contact" with these voters. This activity does not get to the core of determining who is and who isn't eligible to vote.

3). ERIC's unwillingness to address concerns of left-leaning biases and influences. For example, the organization's acceptance of large amounts of money in the form of grants from leftist groups such as the Zuckerberg philanthropies and the George Soros-funded Pew Charitable Trusts. In fact, left-leaning attorney, David Becker, founded ERIC with grant money from Pew Charitable Trusts. Additionally, ERIC received a \$70 million grant from Zuckerberg to fund "voter education programs" and to mobilize voter turnout in favor of the Democrat candidate in battleground states such as PA, MI, GA, and AZ during the 2020 presidential campaign. Accepting and using grant money to advance an agenda shows a clear bias toward a particular candidate or party.

4). Over the past year, seven states have discontinued their membership with ERIC over concerns with data security and ERIC's close affiliation with left-wing organizations. An organization that is tasked with maintaining states' voter rolls should not be accepting funds or engaging in activities that promote one part or the other. Therefore, Hawaii, should not apply to become a member of ERIC.

For these reasons, I firmly oppose SB2240. Thank you for allowing me to submit my written testimony for your consideration.
