### RE: SB 2588, Relating to Historic Preservation

On behalf of Historic Hawai'i Foundation (HHF), I am writing in support for SB 2588, Relating to Historic Preservation.

The bill would appropriate funds for new positions for archaeologists and historic preservation professionals within the Department of Accounting and General Services (DAGS) to provide internal subject matter experts to implement the State's historic preservation goals and expedite compliance with state and federal historic preservation laws for projects under DAGS' area of responsibility.

HHF supports efforts to ensure that the State has a robust, functional and well-resourced historic preservation program to meet the legislative intent in HRS 6E-1 that:

"It shall be the public policy of this State to provide leadership in preserving, restoring, and maintaining historic and cultural property, to ensure the administration of such historic and cultural property in a spirit of stewardship and trusteeship for future generations, and to conduct activities, plans, and programs in a manner consistent with the preservation and enhancement of historic and cultural property."

While oversight and responsibility for the State's historic preservation program rests with the Department of Land and Natural Resources Historic Preservation Division (SHPD), its role is often reactionary. SHPD's workload is heavily weighted towards review, comment and resolution of effects to historic properties from

proposals from others—both public and private entities—rather than affirmatively moving forward with historic property identification and preservation initiatives.

As a result, SHPD relies on project proponents to provide complete submittals for review, to understand the roles and responsibilities for identifying historic and cultural properties, and to propose means to avoid, minimize or mitigate effects of the projects on the resources. When the agencies lack the expertise or understanding to do so, the entire process is slow, inefficient and ineffective.

Most State agencies do not have in-house subject matter experts in archaeology, historic architecture, history or cultural resource management. As a result, the agencies struggle to provide accurate, timely and complete submittals to SHPD for the review and compliance processes. SHPD then spends inordinate amounts of time trying to elicit the appropriate information for a complete submittal package before the review process can even commence. This adds time, cost and frustration to the process. Neither the historic properties nor the proposed project benefit in this scenario.

The bill would address this issue by enhancing and supplementing the capacity at DAGS for professionally qualified administrative staffing to adequately meet legal mandates, to understand and manage the interagency review process and better promote preservation of State properties.

This is an important step to improve the timeliness of reviews for projects, to identify historic properties and features and to reach resolution on the best treatments for historic and cultural resources in State-initiated projects.

### In consideration of SENATE BILL 2588 RELATING TO HISTORIC PRESERVATION

Senate Bill 2588 would provide funds and creates positions to the Department of Accountings and General Services (DAGS) to carry out its duties more effectively under chapter 6E, Hawaii Revised Statutes (HRS). The Department of Land and Natural Resources (Department) supports this measure.

Senate Bill 2588 establishes four positions in DAGS, three archaeologists and one historic preservation specialist, and provides funding for them. DAGS, as is the case for all State agencies, is required to notify the Department's State Historic Preservation Division (SHPD) when a project it is undertaking or funding "has the potential to effect historic property" pursuant to section 6E-8, HRS. DAGS, as is likewise the case for nearly all State agencies, lacks the staffing to effectively meet this statutory mandate. As a result, DAGS is challenged to determine which projects need to be submitted to SHPD and which ones need not be. Furthermore, when DAGS determines that a project must be submitted to SHPD to review, DAGS must rely largely or entirely technical consultants because DAGS's existing staff do not necessarily have the technical qualifications to work with effectively.

This bill would address both problems. With the added staff expertise, DAGS will be better able to make meaningful determinations about which projects to submit to SHPD review as required by section 6E-8,

HRS. When DAGS does determine that a project will have to be subject to SHPD review, DAGS will have the staff to work with both its technical consultants and SHPD to complete project reviews under section 6E-8, HRS, in an effective and timely manner, preserving significant historic properties and delivering projects in a timely manner.
