Aloha Chairs Shimabukuro and Chang, Vice Chairs Fevella and Hashimoto, and Members of the Committees:

The Department of Hawaiian Home Lands (DHHL) supports this bill which would add the Chairperson of the Hawaiian Homes Commission or the Chairperson's designee to the Board of Directors of the Hawaii Housing Finance and Development Corporation (HHFDC) as an exofficio nonvoting member.

The DHHL is excited about this potential opportunity for collaborative engagement and direct communication by way of participation as an exofficio nonvoting member on the HHFDC's board of directors. As an exofficio nonvoting member, the HHC Chairperson or Chairperson's designee would pose little to no disadvantage toward the HHFDC's ability to establish quorum.

The Chairperson of the HHC has a fiduciary duty to serve what is currently, approximately 29,000 native Hawaiians on the DHHL applicant waiting list, approximately 10,000 lessee beneficiaries residing on Hawaiian Home Lands, and a little over 200,000 acres of Hawaiian Home Lands. As such, inclusion of the HHC Chairperson/designee would add perspective and potency of substantive ideas, recommendations, and input in the best interest of the three different classes of beneficiaries to the Hawaiian Home Lands Trust. This bill was approved by the Hawaiian Homes Commission and included in the Governor's administrative package by request of our Department.

RELATING TO HAWAIIAN HOME LANDS

The Department of Budget and Finance (B&F) offers comments on this bill.

Senate Bill No. 3213 allocates 1% in transient accommodations tax (TAT) revenues to the Department of Hawaiian Home Lands (DHHL) for the purpose of building affordable housing for individuals on the DHHL waiting list.

B&F notes that the 1% allocation in TAT revenues to DHHL would result in an estimated general fund revenue loss of \$7.8 million for FY 25; \$8.2 million for FY 26; \$8.6 million for FY 27; \$9.0 million for FY 28; \$9.3 million for FY 29; and \$9.7 million for FY 30. In addition, the bill does not designate where the allocated funds should be deposited, nor does it provide an appropriation to DHHL to expend the funds.

EXECUTIVE SUMMARY: Requires one per cent of the transient accommodations tax be allocated to the Department of Hawaiian Home Lands for the purposes of building affordable housing for individuals on the DHHL waiting list.

SYNOPSIS: Amends section 237D-6.5, HRS, to earmark 1% of all Transient Accommodations Tax revenues to the Department of Hawaiian Home Lands for the purposes of building affordable housing for individuals on the DHHL waiting list.

EFFECTIVE DATE: Upon Approval.

STAFF COMMENTS: The proposed measure would perpetuate the earmarking of TAT revenues. Housing those on the DHHL waitlist may provide a societal benefit. But does that justify grabbing a pot of TAT money without going through the normal budgeting process that also considers sweltering primary schools, underfunded state pensions, or disaster relief for rainflooded, lava-burnt, or wildfire-toasted counties as well as the economic decimation wrought by COVID-19?

Rather than the continual earmarking of revenues, a direct appropriation of general funds would be preferable. Earmarking revenues from any tax type for a particular purpose decreases transparency and accountability.

Next, it should be remembered that revenues diverted for a special purpose, in this case to stuff in DHHL's coffers with a broad mission, will not be counted against the state's spending ceiling or debt limit and will obscure the state's true financial condition.
