A BILL FOR AN ACT

RELATING TO KUPUNA CARE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the State must find
- 2 new ways to accommodate a broader range of home- and community-
- 3 based long-term care options for Hawaii's rapidly growing
- 4 elderly population. According to 2015 population data from the
- 5 department of business, economic development, and tourism, there
- 6 are 236,914 persons, or 16.5 per cent of the population, 65
- 7 years and over in Hawaii. The percentage of this population is
- 8 projected to rise to 19.4 per cent by 2020 and 23 per cent by
- 9 2030.
- 10 The legislature further finds that family caregivers play a
- 11 major role in the State's health care system by providing long-
- 12 term care to the elderly. According to AARP, there are 154,000
- 13 unpaid family caregivers in Hawaii, with the average caregiver
- 14 being a 62-year-old married woman who cares for an elderly
- 15 parent or husband while still working. Caregiving for an
- 16 elderly family member takes a toll on caregivers, and care
- 17 recipients often worry they will become a burden on family

2	levels of psychological distress, and caring for elderly family
3	members over extended periods of time without compensation can
4	lead to chronic stress. In some instances, adult children who
5	work on the mainland may have to return home to live, and
6	abandon careers in the process, in order to care for their
7	parents at home, which is the only alternative to expensive
8	institutional care. If the children already live in Hawaii,
9	they often have to quit their jobs to stay home to care for
10	their aging parents, which may result in financial disaster for
11	the family and a loss of tax revenue for the State. While
12	caregivers play a critical role in helping others, it is
13	imperative that caregivers take care of themselves and have the

8	SECTION 3. Section 349-3.1, Hawaii Revised Statutes, is
9	amended to read as follows:
10	"[+]\$349-3.1[+] Kupuna care program. (a) The executive
11	office on aging $[may]$ shall establish the kupuna care program.
12	The program shall provide [affordable and quality home and
13	community-based services. long-term supports and services to
14	address the needs of Hawaii's older adults and their desire to
15	remain in their own homes and communities as they age.
16	(b) The program [may be provided in every county as a
17	function of the aging and disability resource centers.] shall be
18	coordinated and administered by the executive office on aging
19	and implemented through the area agency on aging.
20	(c) Kupuna care shall be delivered through two distinct
21	service options: traditional service delivery or participant-

1	directed	services and support. Based on an individual support
2	plan, eac	h eligible participant may access kupuna care supports
3	and servi	ces through traditional service delivery or
4	participa	nt-directed services and support; provided that:
5	(1)	Traditional service delivery shall deliver to each
6		participant one or more kupuna care core services to
7		address the participant's specific needs that have
8		been identified through the executive office on
9		aging's process for person-centered planning; and
10	(2)	Participant-directed services and support shall
11		address the participant's specific needs that have
12		been identified through the executive office on
13		aging's process for person-centered planning.
14		Participant-directed services and support shall be
15		long-term services and supports that a participant
16		uses to maintain the participant's independence in the
17		community, in which the participant determines what
18		mix of services and support works best for the
19		participant. The participant shall have decision-
20		making authority over the participant's budgeted
21		dollar amount to purchase and manage the participant's

1		needed services and supports based on the
2		participant's person-centered plan. Participant-
3		directed services and support shall provide the
4		participant with a coach to assist the participant
5		with using the services and support in a manner that
6		best supports the participant's ability to maintain
7		independence and enable a quality living experience in
8		the community.
9	<u>(d)</u>	To qualify for the kupuna care program, an individual
10	shall:	
11	(1)	Be a citizen of the United States or a qualified
12		alien; provided that for the purposes of this
13		paragraph, "qualified alien" means a lawfully admitted
14		permanent resident under the Immigration and
15		Nationality Act;
16	(2)	Be sixty years of age or older;
17	(3)	Not reside in a long-term care facility, such as an
18		intermediate care facility, assisted living facility,
19		skilled nursing facility, hospital, community care
20		foster family home, adult residential care home, or
21		expanded adult residential care home; and

1	(4)	Have	impairments of at least:
2		(A)	Two activities of daily living;
3		<u>(B)</u>	Two instrumental activities of daily living;
4		<u>(C)</u>	One activity of daily living and one instrumental
5			activity of daily living; or
6		<u>(D)</u>	Substantive cognitive impairment requiring
7			substantial supervision because the individual
8			behaves in a manner that poses a serious health
9			or safety hazard to the individual or another
10			person.
11	<u>(e)</u>	The a	area agency on aging, through the aging and
12	disability	resc	ource center or other entity designated by the
13	executive	offic	ce on aging, shall conduct an intake and
14	assessment	ofi	ndividuals seeking long-term services and
15	supports t	co det	termine eligibility for the program. The intake
16	and assess	ment	shall include the following:
17	(1)	A sta	tewide uniform intake developed with and adopted
18		by th	ne executive office on aging to preliminarily
19		deter	mine eligibility for public funded services and
20		suppo	orts, including kupuna care services; and

1	(2)	If warranted, a written assessment of the individual's
2		eligibility to utilize statewide uniform comprehensive
3		in-home care within ninety days after written notice
4		of the area agency on aging's decision regarding
5		eligibility for kupuna services; provided that the
6		director's decision shall be issued in writing and
7		shall be final.
8	(f)	Prior to termination of kupuna care services, service
9	providers	shall notify the contracting area agency on aging of
10	the date	and reason for termination. Termination of kupuna care
11	services	may occur if the participant:
12	(1)	Moves and the provider is unable to locate the
13		participant;
14	(2)	Is transferred to another area agency on aging;
15	(3)	Dies;
16	(4)	No longer needs kupuna care services and supports;
17	(5)	Is uncooperative with the service provider;
18	(6)	Is non-compliant with the basic requirements of the
19		program;
20	(7)	Engages in behavior that threatens or demonstrates
21		violence toward the service provider;

1	(8)	Decides the participant no longer needs or wants a
2		particular service;
3	(9)	Uses comparable services from other programs; or
4	(10)	Has a communicable disease that threatens the safety
5		and welfare of the service provider.
6	(g)	All area agencies on aging shall record all consumer
7	data, ass	essments, and service delivery within a statewide
8	consolida	ted database.
9	[- (c)] (h) As used in this section, unless the context
10	otherwise	requires:
11	"Act	ivities of daily living" means the following activities
12	that indi	viduals perform as a part of daily living: eating,
13	dressing,	bathing, toileting, transferring in and out of a bed
14	or chair,	and walking or moving about by other means within the

17	for an in	dividual in a supervised, protective, and congregate

19	"Agi	ng and disability resource centers" means an entity
20	establish	ed by the State as part of the state system of long-
21	term care	, serving as a highly visible and trusted source where

- 1 people of all incomes and ages can get information on the full
- 2 range of long-term support options, and a single point of entry
- 3 for access to public long-term support programs and benefits.
- 4 "Area agency on aging" means a state agency designated to
- 5 develop and administer the area plan for a comprehensive and
- 6 coordinated system of aging services.
- 7 "Assisted transportation" means an individual who has
- 8 difficulties, cognitive or physical in nature, and who needs
- 9 assistance in using regular vehicular transportation.
- "Attendant care" means stand-by assistance, supervision, or
- 11 cues, and may include other activities to help maintain the
- 12 independence of an individual at home. Attendant care shall not
- 13 include providing hands-on-the-body support, including but not
- 14 limited to weight-bearing assistance with transfers; washing,
- 15 bathing, or grooming a participant's body; or guiding a
- 16 participant's limbs or implements to assist with feeding or
- 17 dressing.
- 18 "Care coordination" means a person-centered, assessment-
- 19 based, interdisciplinary approach to integrating health care and
- 20 social support services that are tailored to an individual's
- 21 needs and goals across all care services.

1	<u>"Cas</u>	se management" means assistance either in the form of
2	access or	care coordination in circumstances where an individual
3	is experi	encing diminished functioning capacities, personal
4	condition	s, or other characteristics that require the provision
5	of service	es by formal service providers or family caregivers.
6	Activitie	s of case management may include assessing needs,
7	developin	g care plans, authorizing and coordinating services
8	among pro	viders, and providing follow-up and reassessment, as
9	required.	
10	"Cho	res" means activities such as heavy housework, yard
11	work, or	general home maintenance.
12	<u>"Coa</u>	ch" means an individual who:
13	(1)	Helps the self-directing participant understand the
14		program of self-directed supports;
15	(2)	Develops and implements a spending plan to describe
16		how the participant will spend the participant's
17		budget; and
18	(3)	Evaluates whether the self-direction program is
19		meeting the participant's needs.
20	"Fam	ily caregivers" means a spouse, adult child, other
21	relative,	partner, or friend who has a personal relationship

1	"Nutrition and meal delivery" means the delivery of a meal
2	to a qualified individual at the individual's place of
3	residence.
4	"Person-centered plan" means a plan developed by a
5	participant with the assistance of a coach that allows the
6	participant to establish goals, skills, and knowledge necessary
7	to work toward the desired outcomes and lays out practical steps
8	to the achievement of the goals; provided that family members
9	and friends may provide assistance in developing a participant's
10	plan if the participant chooses to include them.
11	"Person-centered planning" means a process, directed by the
12	participant, intended to identify the strengths, capacities,
13	preferences, needs, and desired outcomes of the participant.
14	"Personal care" means personal assistance, including hands-
15	on-the-body support, stand-by assistance, supervision, or cues,
16	to assist a participant with activities of daily living.
17	"Qualified individual" means an individual who is sixty
18	years of age or older and homebound by reason of illness or
19	incapacitating disability, or is otherwise isolated.
20	"Transportation" means transportation from one location to
21	another with a vehicle and does not include any other activity.

Kupuna Care; Caregivers; Executive Office on Aging;
Appropriation

Description:

Requires the executive office on aging to establish the kupuna caregivers program to assist community members who are providing care for elders to stay in the workforce. Clarifies the kupuna service and support options provided by area agencies on aging within the kupuna care program. Appropriates funds for establishing and implementing the kupuna caregivers program.
