A BILL FOR AN ACT

RELATING TO TRAFFIC VIOLATIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 291-25, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "§291-25 Lights for motor vehicles, motorcycles, motor
- 4 scooters, motorized bicycles. (a) [From thirty minutes after
- 5 sunset until thirty minutes before sunrise, every | Every motor
- 6 vehicle moving upon any public highway shall carry at the front
- 7 thereof at least two lighted head lamps which shall display
- **8** white lights of equal candle power [-]:
- 9 (1) From thirty minutes after sunset until thirty minutes
- 10 before sunrise; or
- 11 (2) When visibility is less than five hundred feet.
- 12 The head lamps shall be securely mounted, not less than twenty-
- 13 two inches nor more than fifty-four inches above the road
- 14 surface when measured to the head lamp center, on a rigid part
- 15 of the vehicle designed specifically for head lamp installation
- 16 by the manufacturer, and so arranged, adjusted, and constructed
- 17 that, when the motor vehicle is fully loaded, any pair of

- 1 headlights under the conditions of use shall produce a light
- 2 sufficient to reveal any person, vehicle, or substantial object
- 3 on the highway straight ahead of the motor vehicle for a
- 4 distance of two hundred feet.
- 5 The light when measured at a distance of one hundred feet
- 6 directly in front of the motor vehicle, and at a height of sixty
- 7 inches above the level surface on which the motor vehicle
- 8 stands, shall not exceed two thousand four hundred apparent
- 9 candle power, nor shall this candle power be exceeded at a
- 10 greater height than sixty inches.
- 11 When measured at a distance of one hundred feet ahead of
- 12 the motor vehicle and seven feet or more to the left of the axis
- 13 of the same, and at a height of sixty inches above the level
- 14 surface on which the motor vehicle stands, the light shall not
- 15 exceed eight hundred apparent candle power.
- 16 (b) [During the time specified in subsection (a), every]
- 17 Every motorcycle, motor scooter, or motorized bicycle while
- 18 moving on a public highway shall carry, at the front thereof, at
- 19 least one lighted headlight which shall give a light of such
- 20 power and so distributed as provided in subsection (a); provided
- 21 that any motorcycle, motor scooter, or motorized bicycle with a

- 1 side car or similar contrivance attached shall, in addition to
- 2 the foregoing required light, carry on the side car or similar
- 3 contrivance a lighted lamp visible from a point at least two
- 4 hundred feet ahead of the vehicle. Any headlight required by
- 5 this subsection shall display white light during the time and
- 6 under the circumstances as specified in subsection (a), and
- 7 shall be securely mounted, not less than twenty-four inches nor
- 8 more than fifty-four inches above the road surface when measured
- 9 to the headlight's center on a rigid part of the vehicle
- 10 designed specifically for installation of a light by the
- 11 manufacturer."
- 12 SECTION 2. Section 291-29, Hawaii Revised Statutes, is
- 13 amended to read as follows:
- 14 "§291-29 Lights for other vehicles. All vehicles other
- 15 than those specified in section 291-25 shall during the time and
- 16 under the circumstances mentioned in such section when upon the
- 17 public highway, carry a lighted light on the extreme width of
- 18 each side so arranged that a light from the lamps shall be
- 19 visible in every direction at least two hundred feet."
- 20 SECTION 3. Section 291-32, Hawaii Revised Statutes, is
- 21 amended by amending subsection (a) to read as follows:

- 1 "(a) The use or operation of any motor vehicle not
- 2 equipped with lights in conformity with sections 291-25 to 291-
- 3 31 upon the public highways is prohibited during the [period]
- 4 time and under the circumstances as specified in section 291-
- **5** 25(a)."
- 6 SECTION 4. Statutory material to be repealed is bracketed
- 7 and stricken. New statutory material is underscored.
- 8 SECTION 5. This Act shall take effect on July 1, 2050.
