A BILL FOR AN ACT

RELATING TO INTOXICATING LIQUOR.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that a number of outdoor 2 festivals, parades, and races take place on the streets of
- 3 neighborhoods each year. These require certain streets to be
- 4 closed to traffic using permits granted by the department of
- 5 transportation. In some cases, event organizers are granted
- 6 special permits by the counties' liquor commissions allowing
- 7 them to serve alcohol. There is a range of sentiment coming
- 8 from residents, property owners, business owners, and others
- 9 regarding the possible impact of the sale of alcohol at some
- 10 events on crowd behavior, noise, and other types of nuisance.
- 11 The purpose of this Act is to clarify the setting in which
- 12 outdoor alcohol special licenses may be issued.
- 13 SECTION 2. Section 281-1, Hawaii Revised Statutes, is
- 14 amended by adding a new definition to be appropriately inserted
- 15 and to read as follows:
- ""Beer garden" means a defined, outdoor premise of not more
- 17 than three thousand contiquous square feet that is open to the



- 1 public and consists of boundaries enclosed with a solid barrier
- 2 of no less than forty-two inches in height, as measured from the
- 3 floor to the top, constructed of wood, concrete, plastic, rope,
- 4 wrought iron fencing, or other material approved by the
- 5 commission, in which beer, wine, and spirits are sold and
- 6 consumed."
- 7 SECTION 3. Section 281-31, Hawaii Revised Statutes, is
- 8 amended by amending subsection (j) to read as follows:
- 9 "(j) Class 10. Special license.
- 10 (1) A special license may be granted for the sale of 11 liquor for a period not to exceed three days and 12 pursuant to commission rule may be approved by the 13 administrator for fundraising events by nonprofit 14 organizations, political candidates, and political 15 parties; provided that any registered educational or 16 charitable nonprofit organization may sell liquors in 17 their original packages for off-premises consumption; 18 provided further that any social club granted tax-19 exempt status pursuant to section 501(c)(7) of the 20 Internal Revenue Code of 1986, as amended, may sell 21 wine from the social club's inventory to the club's

1		members for off-premises consumption. Of this class,
2		there shall be the following kinds:
3		(A) General (includes all liquor except alcohol);
4		(B) Beer and wine; and
5		(C) Beer.
6		Liquor sold under a class 10 license shall be consumed
7		on the premises[+]; provided that a class 10 license
8		shall not be granted for an outdoor premise unless
9		liquor shall be sold and consumed only within a beer
10		garden.
11	(2)	Notwithstanding any other section of this chapter to
12		the contrary, the commission shall waive any hearings,
13		fees, notarization of documents, submission of floor
14		plans and other governmental clearances, and other
15		requirements for the issuance of a class 10 license.
16		The class 10 license granted under this subsection for
17		a fundraising event shall include the ability to
18		auction off, at a live or silent auction, liquor in
19		sealed or covered glass, ceramic, or metal containers

or services that provide liquor. No criminal history

2	commission may require proof of liquor liability
3	insurance for the fundraising event and a current list
4	of officers and directors if the applicant is a

8	SECTION 5. This Act shall take effect upon its approval.
