A BILL FOR AN ACT

RELATING TO GRANTS FOR LOCAL RECYCLING FACILITIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Hawaii has grappled
- 2 with solutions to deal with municipal waste for decades.
- 3 Landfill capacity is rapidly decreasing, even after creating
- 4 mitigation measures like exportation and incineration.
- 5 Currently, the vast majority of recyclable materials are
- 6 recycled outside the State. Landfill diversion has global
- 7 environmental benefits, including reducing the need to extract
- 8 raw materials from mines, such as aluminum, and decreasing the
- 9 amount of methane gas released into the atmosphere as waste
- 10 decomposes. Landfills are the third largest source of methane
- 11 emissions in the United States behind industry and agricultural
- 12 sources. According to the United States Environmental
- 13 Protection Agency, methane is the second most prevalent
- 14 greenhouse gas emitted in the United States from human
- 15 activities, which has a significant impact on climate change.
- 16 The legislature further finds that an investment in local
- **17** recycling facilities is immediately necessary to address the

- 1 human impact on Hawaii's natural environment and mitigate the
- 2 effects of the climate crisis.
- 3 The purpose of this Act is to incentivize the development
- 4 of recycled products manufacturing, bioconversion, or composting
- 5 businesses within the State.
- 6 SECTION 2. Chapter 342G, Hawaii Revised Statutes, is
- 7 amended by adding a new section to be appropriately designated
- 8 and to read as follows:
- 9 "§342G- Recycled products manufacturing grant program;
- 10 established. (a) There is established in the office a recycled
- 11 products manufacturing grant program to be administered by the
- 12 department. The department shall issue grants to recycled
- 13 products manufacturers or bioconversion or composting businesses
- 14 to assist them in offsetting the costs of operations within the
- 15 State.
- (b) Grants awarded under this section shall meet a
- 17 standard as determined by the department. Grants made by the
- 18 department under this section shall be exempt from chapter 103D.
- 19 (c) Applications for the grants shall be submitted on a
- 20 form furnished by the department and shall be filed with any
- 21 accompanying documentation as may be required by the office.

- 1 (d) Grant program funds shall be disbursed from the 2 environmental management special fund established under section 3 342G-63, upon approval by the department, to the grantee for up 4 to \$750,000. 5 The department shall adopt rules pursuant to chapter 6 91 as necessary to carry out the purposes of this section. 7 (f) For the purposes of this section, "recycled products" means the collection, separation, recovery, and sale or reuse of 8 9 locally sourced recyclables within the State that would 10 otherwise be disposed of as municipal solid waste, and is an 11 integral part of a manufacturing process aimed at producing a marketable product made of postconsumer material within the 12 13 State." 14 SECTION 3. Section 342G-14, Hawaii Revised Statutes, is 15 amended to read as follows: 16 "[f] §342G-14[f] Powers and duties of the office of solid 17 waste management. The office shall:
- 20 (2) Identify and monitor environmental and public health
 21 issues relating to solid waste management;

Promote the development of coordinated statewide solid

3	(8)	Coordinate the bioconversion efforts of appropriate
4		agency and county activities, including the provision
5		of technical assistance and the evaluation of
6		bioconversion programs;
7	(9)	Provide waste evaluation services and assistance in
8		developing paper recycling and other materials
9		programs to both the public and private sector, where
10		feasible;
11	(10)	Promote the use of enterprise zones in each county to
12		support source reduction, recycling, and
13		bioconversion-type businesses;
14	(11)	Establish a recycled products manufacturing grant
15		program to incentivize new recycled products
16		manufacturing, bioconversion, or composting businesses
17		in the State;
18	[(11)]	(12) Create and maintain a database to assess the
19		composition of the State's waste stream. If feasible,
20		this database shall contain the information necessary
21		to generate the office's annual report:

1 $[\frac{(12)}{(13)}]$ (13) Identify and apply for appropriate federal funds 2 to support the programs and activities authorized by 3 this chapter; and 4 $[\frac{(13)}{(14)}]$ (14) Cooperate with appropriate federal, state, and 5 county agencies in carrying out the office's 6 responsibilities under this chapter." 7 SECTION 4. There is appropriated out of the general 8 revenues of the State of Hawaii the sum of \$ or so 9 much thereof as may be necessary for fiscal year 2020-2021 to be 10 deposited into the environmental management special fund. 11 SECTION 5. There is appropriated out of the environmental 12 management special fund the sum of \$ or so much 13 thereof as may be necessary for fiscal year 2020-2021 for the 14 recycled products manufacturing grant program. 15 The sum appropriated shall be expended by the department of 16 health for the purposes of this Act. 17 SECTION 6. Statutory material to be repealed is bracketed 18 and stricken. New statutory material is underscored. 19 SECTION 7. This Act shall take effect on July 1, 2050.
