A BILL FOR AN ACT

RELATING TO GRANTS FOR LOCAL RECYCLING FACILITIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Hawaii has grappled
- 2 with solutions to deal with municipal waste for decades.
- 3 Landfill capacity is rapidly decreasing, even after creating
- 4 mitigation measures like exportation and incineration.
- 5 Currently, the vast majority of recyclable materials are
- 6 recycled outside the State. Landfill diversion has global
- 7 environmental benefits, including reducing the need to extract
- 8 raw materials from mines, such as aluminum, and decreasing the
- 9 amount of methane gas released into the atmosphere as waste
- 10 decomposes. Landfills are the third largest source of methane
- 11 emissions in the United States behind industry and agricultural
- 12 sources. According to the United States Environmental
- 13 Protection Agency, methane is the second most prevalent
- 14 greenhouse gas emitted in the United States from human
- 15 activities, which has a significant impact on climate change.
- 16 The legislature further finds that an investment in local
- 17 recycling facilities is immediately necessary to the human



- 1 impact on Hawaii's natural environment and mitigate the effects
- 2 of the climate crisis.
- 3 The purpose of this Act is to incentivize the development
- 4 of new recycling, bioconversion, or composting businesses within
- 5 the State of Hawaii.
- 6 SECTION 2. Chapter 342G, Hawaii Revised Statutes, is
- 7 amended by adding a new section to part V to be appropriately
- 8 designated and to read as follows:
- 9 "\$342G- Recycling facility grant program . (a) There
- 10 is established in the office within the department a recycling
- 11 facility grant program to be administered by the department.
- 12 The department shall issue grants to recycling facility
- 13 operators to assist them in offsetting the costs of operations
- 14 within the State.
- 15 (b) Grant program funds shall be disbursed from the
- 16 environmental management special fund established under section
- 17 342G-63 upon approval by the department, to the recycling
- 18 facility operator for up to \$750,000.
- (c) Any recycling facility operator requesting a grant

There is appropriated out of the general revenues of the State of Hawaii the sum of \$ 5 much thereof as may be necessary for fiscal year 2020-2021 to be 6 deposited into the environmental management special fund. 7 8 SECTION 5. There is appropriated out of the environmental 9 management special fund the sum of \$ or so much 10 thereof as may be necessary for fiscal year 2020-2021 for the 11 implementation of the recycling facility grant program pursuant 12 to this Act, including one full-time equivalent (1.0 FTE) 13 contract specialist position . 14 The sum appropriated shall be expended by the office of 15 solid waste management for the purposes of this Act. SECTION 6. Statutory material to be repealed is bracketed 16 17 and stricken. New statutory material is underscored.

SECTION 7. This Act shall take effect on July 1, 2020.
