A BILL FOR AN ACT

RELATING TO THE ENVIRONMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Hawaii's natural
- 2 resources, including reefs, beaches, oceans, forests, streams,
- 3 estuaries, and shorelines, provide irreplaceable and invaluable
- 4 benefits to residents and visitors. These natural resources are
- 5 critical to generating billions of dollars for Hawaii's economy
- 6 and the local community and supporting thousands of jobs for
- 7 residents. Hawaii's natural resources are inseparable from the
- 8 State's culture and directly support the visitor industry and
- 9 the livelihoods that depend on the visitor industry.
- 10 The legislature further finds that despite the incredible
- 11 value of Hawaii's natural resources, the State currently invests
- 12 less than one per cent of its budget to protect, restore, and
- 13 manage these assets. To leave a healthy natural resources
- 14 legacy for future generations of Hawaii residents and visitors,
- 15 the State must urgently address the estimated \$360,000,000
- 16 annual conservation funding gap, and provide sustained,

- 1 increased funding for Hawaii's natural resources and
- 2 environment.
- 3 The legislature also finds that Hawaii's natural
- 4 environment faces significant environmental pressures from heavy
- 5 use by persons traveling from throughout the world to enjoy the
- 6 State's natural beauty and resources. Hawaii's natural
- 7 environment also faces increasing challenges as a result of
- 8 climate change. Continuing to underinvest in the protection and
- 9 care of Hawaii's natural resources poses a significant liability
- 10 to the State's visitor industry, the stability of the natural
- 11 systems, including water quality, and economic resilience.
- 12 Hawaii residents already contribute significantly to the
- 13 protection and management of the State's natural resources
- 14 through taxes. With escalating visitor impacts, there is an
- 15 immediate need for additional resources to protect, restore, and
- 16 manage Hawaii's natural resources.
- 17 The legislature believes that it is reasonable and timely
- 18 to ask visitors to Hawaii who enjoy local natural resources to
- 19 further contribute to the protection, restoration, and care of
- 20 these resources. Visitor green fees have been successfully
- 21 implemented in other visitor destinations around the world,

- 1 including the Galapagos Islands, New Zealand, and Palau. A
- 2 visitor green fee program will provide additional resources to
- 3 protect Hawaii's natural resources for the enjoyment of future
- 4 generations while supporting the creation of thousands of jobs
- 5 for Hawaii residents. A \$50 fee paid by visitors who enjoy
- 6 Hawaii's public parks, beaches, and trails could generate up to
- 7 \$400,000,000 each year to enable the State to leave future
- 8 generations with a healthy and safe environment.
- 9 The legislature additionally finds that a visitor green fee
- 10 program can support economic diversification and create
- 11 thousands of public and private jobs in Hawaii's economy. A
- 12 visitor green fee program can also help finance the achievement
- 13 of the 2030 Aloha+ challenge natural resource management target,
- 14 adopted by the State in July 2014, and supported by the
- 15 legislature, governor, four county mayors, office of Hawaiian
- 16 affairs, and partners across the State. The legislature now
- 17 believes it is imperative to raise additional revenues to leave
- 18 a positive environmental legacy for Hawaii's future generations
- 19 and that a visitor green fee will provide a reasonable and
- 20 appropriate way to generate these needed revenues.
- 21 Accordingly, the purpose of this Act is to:



1	(1)	Require the department of land and natural resources
2		to establish a visitor green fee program to collect
3		fees from visitors to the State for the provision of
4		sustained and increased funding for the protection,
5		restoration, and care of Hawaii's natural, cultural,
6		and outdoor recreational resources and build the
7		resilience of these resources to the impacts of
8		climate change and local threats;
9	(2)	Establish the Hawaii environmental legacy commission
10		to guide the disbursement of funds collected from the
11		visitor green fee program; and
12	(3)	Establish the Hawaii environmental legacy special
13		fund.
14	SECT	ION 2. Chapter 171, Hawaii Revised Statutes, is
15	amended b	y adding a new part to be appropriately designated and
16	to read a	s follows:
17		"PART . VISITOR GREEN FEE PROGRAM
18	§171	-A Definitions. As used in this part:
19	"Com	mission" means the Hawaii environmental legacy
20	commissio	n.
21	"Fee	" means the visitor green fee.

2 allows visitors to use state natural resources, including 3 beaches, parks, trails, coastlines, and the environment. "Local public agency" includes but is not limited to a 4 5 county, district, or special agency. 6 "Nonprofit organization" means a private, nonprofit 7 organization with nonprofit status acknowledged by the United States Internal Revenue Service that qualifies under section 9 501(c)(3) of the Internal Revenue Code, as amended, and has 10 among its charitable purposes the preservation, restoration, 11 management, or interpretation of natural or cultural resources for scientific, historic, educational, recreational, scenic, 12 13 wildlife, or open-space purposes, the protection of the natural 14 environment or biological resources, the preservation or 15 enhancement of wildlife, or the protection or interpretation of native Hawaiian cultural resources. 16 "Nonresident" means an individual who is not a resident. 17 18 "Program" means the Hawaii environmental legacy program. "Resident" means an individual who has: 19 20 (1) Filed or paid state income taxes for the immediately 21 previous tax period; or

"License" means the license issued by the department that

I	(2)	Established domicile in the State, as evidenced by
2		documentation showing the individual's address,
3		including any of the following:
4		(A) A valid state driver's license;
5		(B) A valid state civil identification card;
6		(C) A valid school identification card; or
7		(D) Any other official document issued to the
8		individual by a government agency, financial
9		institution, insurance company, or utility
10		company in the State.

13	§171	-B Visitor green fee program. (a) There is
14	establish	ed a visitor green fee program to advance the 2030
15	Aloha+ cha	allenge natural resource management targets. Under the
16	program,	to be administered by the department, nonresidents
17	shall pay	the visitor green fee in order to obtain a license to
18	use Hawaii	i's public beaches, parks, trails, coastlines, and
19	environme	nt. Visitor green fees collected shall be deposited
20	into the B	Hawaii environmental legacy special fund established
21	pursuant t	to section 171-D.

- 1 (b) Beginning July 1, 2023, it shall be unlawful for any
- 2 nonresident of the State who has attained the age of fifteen,
- 3 except for members of the armed forces of the United States of
- 4 America on active duty, to visit a state park, beach, state-
- 5 owned forest, or other state-owned natural area or hike on a
- 6 trail on state-owned land without first obtaining a license
- 7 pursuant to this part.
- 8 (c) The department shall establish convenient
- 9 opportunities for nonresidents to purchase a license, including
- 10 through a mobile application and an internet website. The
- 11 department may also establish a separate retail license program
- 12 to enable retail establishments and nonprofit organizations to
- 13 sell licenses.
- 14 (d) The initial visitor green fee shall be \$50 per person.
- 15 (e) The chairperson may adjust the fee by rule no more
- 16 than once every five years, at the rate of the consumer price
- 17 index change from July 1, 2023, compounded annually, and rounded
- 18 to the nearest dollar.
- (f) A license shall be in effect for a three hundred
- 20 sixty-five day period, including the day of issuance.

1	(g) The department may adopt rules pursuant to chapter 91
2	as necessary to effectuate the purposes of this section.
3	§171-C Hawaii environmental legacy commission. (a) There
4	is established within the department the Hawaii environmental
5	legacy commission to guide the department's disbursement of the
6	visitor green fee funds to achieve the 2030 Aloha+ challenge
7	natural resource management targets, support conservation
8	workforce development and economic diversification, and ensure
9	stakeholder engagement, transparency, and effectiveness of the
10	program.
11	(b) The commission shall be composed of the following
12	voting members, to be appointed without need for confirmation by
13	the senate:
14	(1) One representative of a nonprofit environmental
15	organization with expertise in the protection,
16	restoration, and care of terrestrial natural
17	resources, to be appointed by the chairperson;
18	(2) One representative of a nonprofit environmental
19	organization with expertise in the protection,
20	restoration, and care of marine and coastal natural
21	resources, to be appointed by the chairperson;

3)	one representative of a nonprofit environmental
	organization with expertise in climate change
	mitigation and resiliency, to be appointed by the
	chairperson;
4)	No more than two members who are staff of the
	department or its attached agencies, to be appointed
	by the chairperson;
5)	The director of the office of planning and sustainable
	development, or the director's designee;
6)	No more than two representatives from the native
	Hawaiian community who have expertise in the
	protection, restoration, care, and interpretation of
	native Hawaiian cultural resources, to be appointed by
	the chairperson;

	executive officer's designee;
8)	One youth representative between the ages of eighteen

1		sustainability or restoration, to be appointed by the
2		chairperson; and
3	(9)	One representative from the visitor and tourism
4		industry, to be appointed by the president and chief
5		executive officer of the Hawaii tourism authority.
6	(c)	Commission members shall annually elect a chairperson
7	and vice-	chairperson of the commission from among its members.
8	(d)	The commission shall approve allocation of funding,
9	including	grants, from funds deposited in the special fund.
10	Monies de	posited into the special fund shall be allocated for
11	direct ex	penditure by state agencies and for grants for projects
12	that dire	ctly support achievement of the 2030 Aloha+ challenge
13	natural r	esource management target, including for projects with
14	one or mo	re of the following purposes:
15	(1)	Protection, restoration, or enhancement of terrestrial
16		or marine natural resources, or a combination thereof;
17		provided that up to ten per cent of each grant awarded
18		may be allocated for resource management to ensure the
19		long-term sustainability of state natural resources;
20	(2)	Enhancement of interpretive and educational facilities
21		and programs related to the State's natural and

1		cultural resources and the protection of those
2		resources;
3	(3)	Increase of resilience and adaptation of the State's
4		natural resources with environmentally beneficial
5		strategies to reduce the adverse impacts of climate
6		change, including coastal erosion, sea level rise,
7		ocean acidification, coral bleaching, destruction of
8		reefs, and other impacts; and
9	(4)	Removal and control of invasive species and
10		propagation and planting of native species.
11	(e)	In awarding grants from the special fund, the
12	commissio	n shall prioritize projects that directly support
13	achieveme	nt of the 2030 Aloha+ challenge natural resource
14	managemen	t target and:
15	(1)	Create jobs for Hawaii residents;
16	(2)	Provide significant long-term protection, restoration,
17		and enhancement of Hawaii's natural and cultural
18		resources;
19	(3)	Increase the enjoyability of participating in outdoor
20		recreational activities for residents and visitors of
21		the State;

l	(4)	Involve local communities in the design,
2		implementation, and long-term management of the
3		project; and

- (5) Protect, enhance, or restore natural resources that contribute to native Hawaiian cultural practices and that have demonstrated support from native Hawaiian residents.
- 8 (f) The commission may adopt procedures and guidelines for 9 the prioritization and allocation of monies from the special 10 fund, including direct grant or competitive grant processes; 11 provided that the commission shall hold at least one hearing in 12 each county to receive public comments before adopting grant 13 guidelines.
- (g) A simple majority of commission members shall establish a quorum necessary to approve allocations from the fund.
- (h) The commission shall hold meetings in public

 18 consistent with chapter 92 and any other applicable laws. The

 19 commission may hold its meetings in person or online via the

 20 Internet, or a combination thereof.

1	(i) Commission members shall serve without compensation
2	but may be reimbursed for reasonable expenses, including travel
3	expenses, necessary for the performance of their duties.
4	(j) Beginning January 2025, the department shall publish
5	an annual report, to be reviewed by the commission, no later
6	than twenty days prior to the convening of each regular session
7	of the legislature on how the Hawaii environmental legacy
8	special fund achieves the 2030 Aloha+ challenge natural resource
9	management target and the benefits that accrue or will accrue
10	from those expenditures to state residents, visitors, and
11	natural resources.
12	§171-D Hawaii environmental legacy special fund. (a)
13	There is established in the state treasury a Hawaii
14	environmental legacy special fund, into which shall be
15	deposited:
16	(1) All proceeds from visitor green fees and licenses
17	purchased pursuant to the visitor green fee program
18	established under section 171-B;
19	(2) Appropriations made by the legislature; and
20	(3) Grants and gifts made to the special fund.



1	(d)	Monies deposited into the special fund shall be used
2	and alloc	ated as directed by the commission pursuant to section
3	171-C(d)	and (e) and as follows:
4	(1)	At least fifty per cent per fiscal year shall be used
5		for grants to local governments, nonprofit
6		organizations, and community-based organizations;
7	(2)	No more than fifty percent per fiscal year shall be
8		allocated to state agencies;
9	(3)	Up to twenty-five per cent per fiscal year may be used
10		to enhance state management of natural resources,
1		implementation of state regulatory programs designed
12		to protect natural resources, and enforcement of
13		natural resource protection laws and regulations;
 4	(4)	No more than five per cent per fiscal year of the
15		amount allocated to state agencies pursuant to
16		paragraph (2) shall be used to administer this part;
17		and
18	(5)	No less than ninety-five percent per fiscal year shall
19		be used for the purposes described in this section."
20	SECT	ION 3. In codifying the new sections added by section
21	2 of this	Act, the revisor of statutes shall substitute
