"HOUSE RESOLUTION REQUESTING THE DEPARTMENT OF EDUCATION TO CONVENE A WORKING GROUP TO DEVELOP A WRITTEN PLAN FOR EVERY PUBLIC SCHOOL ELEMENTARY, MIDDLE, AND HIGH SCHOOL TO PROVIDE A UNIT OF INSTRUCTION IN ASIAN AMERICAN AND PACIFIC ISLANDER HISTORY AS PART OF THEIR REQUIRED CURRICULUM, COMMENCING WITH THE 2024-2025 SCHOOL YEAR,"

The purpose of this measure is to develop a written plan for every public elementary, middle, and high school to provide a unit of instruction in Asian American and Pacific Islander history as part of each school's required curriculum.

Your Committee received testimony with comments on this measure from the Department of Education.

Your Committee finds that teaching students about the contributions of Asian American and Pacific Islander communities to the economic, cultural, social, and political development of the United States could be greatly beneficial and would allow students to feel empowered and to understand their ethnic identities. This measure asks for the incorporation of these histories in the curriculum at different levels of education and will be useful for
