# A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The purpose of this Act is to appropriate funds
2	to the University of Hawaii Pamantasan Council for three full-
3	time equivalent (3.0 FTE) positions.
4	SECTION 2. There is appropriated out of the general
5	revenues of the State of Hawaii the sum of \$310,000 or so much
6	thereof as may be necessary for fiscal year 2023-2024 and the
7	same sum or so much thereof as may be necessary for fiscal year
8	2024-2025 to fund the establishment of the following positions
9	for the University of Hawaii Pamantasan Council:
10	(1) One full-time equivalent (1.0 FTE) permanent faculty
11	position at Leeward community college;
12	(2) One full-time equivalent (1.0 FTE) permanent faculty
13	position at the University of Hawaii Maui college; and
14	(3) One full-time equivalent (1.0 FTE) permanent
15	administrative, professional, and technical position

at the University of Hawaii at Manoa.

1 The sums appropriated shall be expended by the University 2 of Hawaii for the purposes of this Act. 3 SECTION 3. In accordance with section 9 of article VII of the Hawaii State Constitution and sections 37-91 and 37-93, 4 5 Hawaii Revised Statutes, the legislature has determined that the appropriations contained in H.B. No. 300, H.D. 1, S.D. 1, 6 7 C.D. 1, will cause the state general fund expenditure ceiling 8 for fiscal year 2023-2024 to be exceeded by \$1,063,767,367 or 9 10 per cent. In addition, the appropriations contained in this 10 Act will cause the general fund expenditure ceiling for fiscal 11 year 2023-2024 to be further exceeded by \$310,000 or 1 per cent. 12 The combined total amount of general fund appropriations 13 contained in only these two Acts will cause the state general fund expenditure ceiling for fiscal year 2023-2024 to be 14 15 exceeded by \$1,064,077,367 or 11 per cent. The reasons for 16 exceeding the general fund expenditure ceiling are that: 17 (1)The appropriation made in this Act is necessary to 18 serve the public interest; and 19 (2)The appropriation made in this Act meets the needs 20 addressed by this Act.
